The Commission therefore has the statutory obligation to assess an applicant's qualifications based upon the applicant's identity, its principals, its citizenship, alien involvement (if any), financial qualifications, other media interests, character qualifications, and compliance with the Anti-Drug Abuse Act of 1988, 21 USC §862.</p> <p>It is respectfully submitted that the documentation listed in Sections 1(b) and 1(c) of the Asset Purchase Agreement (not scheduled) is not relevant to the Commission's consideration of this application. Specifically, the contracts that Buyer has agreed to assume are not relevant to a determination of the qualifications of the parties to the application. Accordingly, there is no public interest requirement for these private contractual arrangements to be freely available in the public domain.</p>

A	OUTSOURCING AGREEMENT	<i>See</i> the narrative and explanation regarding Sections 1(b) and 1(c). It is respectfully submitted that the same rationale applies to this exhibit. Exhibit A is a form of Outsourcing Agreement which will be executed by the parties only in the event that Buyer is unable to acquire the construction permit for the new Bay City station (File No. BPCT-19960710KZ) solely because of Buyer's existing ownership of another full-power television station in the Flint, Michigan DMA. In that event, Seller and Buyer shall execute an Outsourcing Agreement at the closing substantially in the form of Exhibit A, at which time all of the assets other than the FCC construction permit will be assigned to Buyer. Due to the contingent nature of the outsourcing arrangement, Exhibit A is not relevant to a determination of the qualifications of the parties to the application.
