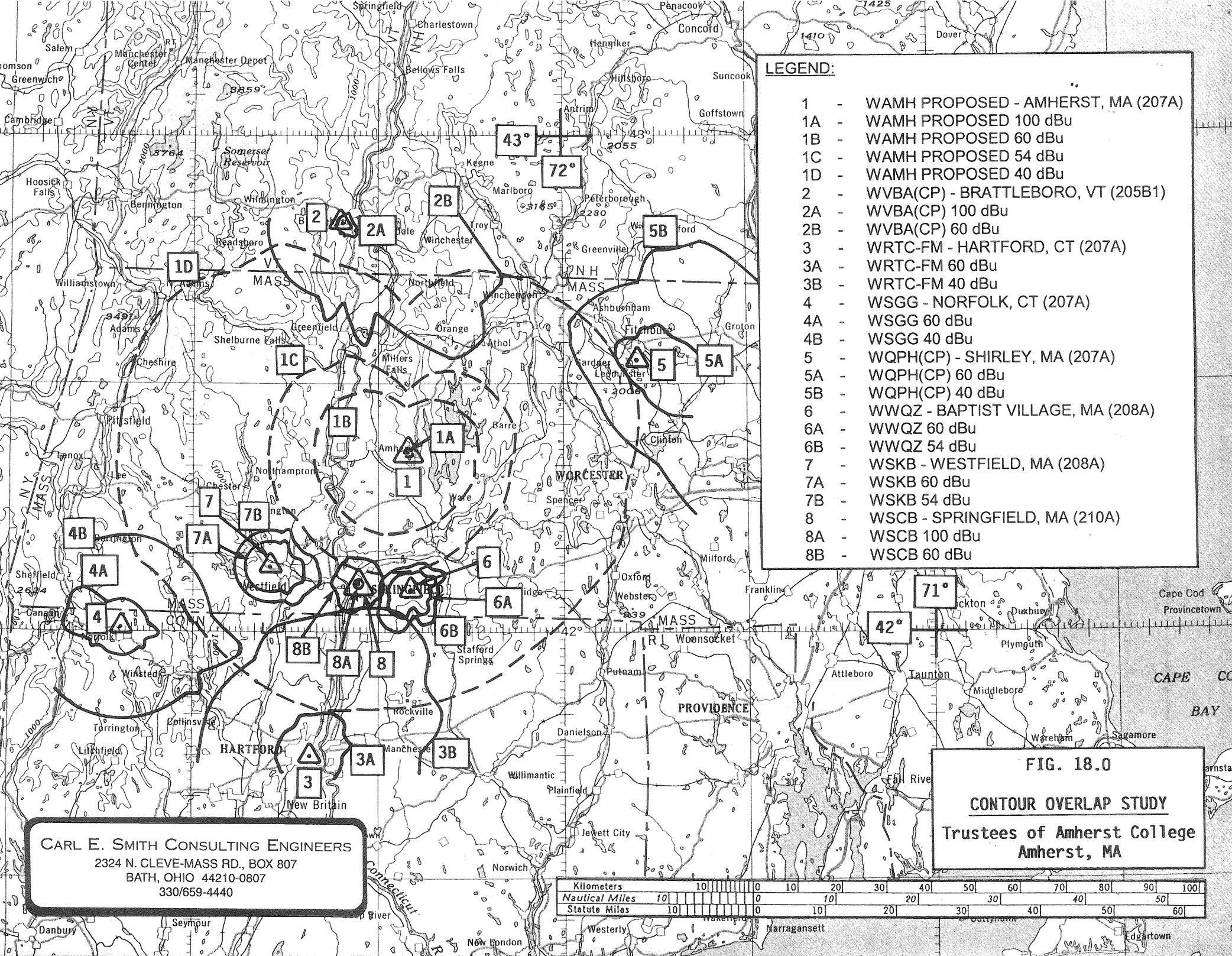

Figure 18.0 shows the service and interference contours for the proposed WAMH facilities in relation to those of all other domestic stations, both operating and proposed, on Channels 204 through 210 that require protection consideration. All contours were projected using the notified facilities for each station from the FCC's Consolidated Database System ("CDBS") and terrain data extracted from the NGDC 30 second terrain database. As shown in this figure, the proposed facilities will not cause or receive any prohibited contour overlap with any other station that requires protection consideration.

Table 18.0 shows the actual and required separations between the proposed facilities and all Canadian stations operating on Channels 204 through 210 and all stations and allotments on Channels 260 and 261. This table shows that the proposed facilities have adequate separation from all other operating or proposed stations or allotments requiring consideration.

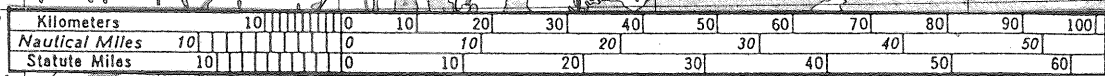
