

This application seeks to simply correct the coordinates of Station KKVV(AM), Las Vegas, Nevada, Fac. ID 36642. No other changes are proposed in the application.

The officers and directors of Las Vegas Broadcasters, Inc. have attributable interests in Southern Nevada Educational Broadcasters ("SNEB"), which is the licensee of noncommercial educational Stations KEKL(FM), Mesquite, Nevada, Facility Id 76248 and KVKL(FM), Las Vegas, Nevada, Fac. ID 88719. Stations KKVV, KEKL and KVKL are located in the Las Vegas Nielsen Audio Metro Market ("Las Vegas Market").

For the purposes of the FCC's multiple ownership rules, the Las Vegas Metro includes the stations licensed to communities located inside the market. Therefore, the Las Vegas Market contains at least the 23 AM and FM stations which are licensed to the city of Las Vegas, including KKVV and KVKL. A list of the stations licensed to the city of Las Vegas is provided below.

In a market with between 15 and 29 full-power, commercial and noncommercial radio stations, a party may have attributable interests in not more than six commercial radio stations in total and not more than four commercial stations in the same service. See 47 C.F.R. § 73.3555(a)(1)(iii). The relevant parties in Las Vegas Broadcasters and SNEB would have attributable interests in only three stations in the Las Vegas Market, both prior to a grant of the instant application and after a grant of the application. Therefore, the changes proposed in the application comply with the Commission's multiple ownership rules.
