K-Six Television, Inc. is 100% controlled by Corpus Christi Broadcasting Co., Inc., which in turn is 100% controlled by Eagle Creek. The officers and directors of Eagle Creek, Corpus Christi Broadcasting Co., Inc., and K-Six Television Co., Inc. will be Brian W. Brady (President, CEO and Director), William R. Quarles (Treasurer), Fred L. Levy (Secretary), Imanta Bergmanis (Assistant Secretary), Catherine B. Gardner (Assistant Secretary), and Timothy L. Dibble (Director).
