Parties to Application

The instant application requests consent to assignment of the license of KEYI(FM), San Marcos, Texas, from Sinclair Telecable, Inc. (“Sinclair”), to LBJS Broadcasting Company, L.P. (“LBJS”).¹

LBJS is a limited partnership whose general partner is Radio Austin Management, L.L.C. (“RAM”). Upon consummation of the assignment contemplated by the instant application, Emmis Operating Company (“EOC”) will have a controlling 50.1% membership interest in RAM, and Sinclair will have a minority 49.9% membership interest. EOC and Sinclair will also be the limited partners of LBJS, with ownership interests of 49.69443% and 49.49605%, respectively.² Accordingly, EOC will be in control of LBJS.³

¹ In a companion application filed concurrently in connection with a related transaction, consent is also requested to transfer control of LBJS, licensee of KLBJ(AM) and KLBJ-FM, Austin; KXMG(FM), Cedar Park; KROX-FM, Buda; and KGSR(FM), Bastrop (all Texas), from LBJ Broadcasting Company, L.P., to Emmis Operating Company.

² The limited partnership interests total less than 100% because RAM will have a 0.80952% ownership interest in LBJS.

³ Consistent with this ownership structure, the assignee’s portion of the application has been signed by an officer of EOC, and the address provided for the assignee is EOC’s address.

Attachment A

Emmis Operating Company (“EOC”) is a wholly-owned subsidiary of Emmis Communications Corporation (“ECC”). Pertinent information concerning EOC and ECC, both of which are U.S. corporations, is attached.

No officer or director of ECC other than Jeffrey H. Smulyan holds a 1% or greater voting interest in the corporation. Mr. Smulyan holds a 50.6% voting interest in ECC, and consequently, under the “single majority shareholder” exemption from the Commission’s attribution rules, minority shareholders in ECC are not deemed to have “attributable” interests in the corporation.¹

No person or entity holds a debt or equity interest in either EOC or ECC attributable under the “EDP” standard (see Section 73.3555, Note 2(h)(i)).

¹ This exemption (formerly contained in Note 2(b) to Section 73.3555) was repealed by the Commission in 2001, but the repeal was “suspended” by *Order* released December 14, 2001 (FCC 01-353). Thus the exemption remains in effect.
