**Agreement of Understanding
Between
KVIE
and
Calvary Chapel of Twin Falls, Inc.**

This agreement is entered into as of the 12 day of August, 1998 by and between KVIE, SACRAMENTO, CA (herein referred to as KVIE), and CALVARY CHAPEL OF TWIN FALLS, INC., et all, a non-commercial FM broadcaster. (herein referred to as CALVARY)

KVIE and CALVARY hereby enter into this agreement in accordance with the requirements specified by FCC Rules and Regulations Part 73.525.

KVIE is concerned with protecting our members and viewers from FM interference, both now and in the future. KVIE will agree to the proposed Calvary translator application under the following criteria:

1. Frequency is 89.5 MHz
2. E.R.P. is 10 watts
3. Transmit Antenna - Vertical Polarization Only (Scala – 2 antenna array CA5
Or CLFM 2 array system-depending on tower space)
See Exhibit A for technical information
4. Antenna elevation RCAMSL is 537 meters with coordinates at
N. Lat. 38-15-51
W. Long. 122-12-54
5. CALVARY specifically agrees to remedy verified cases by competent, trained technical personnel, of off-the-air Calvary interference to the KVIE, Channel 6 signal within the affected NAPA, CA area. Notch type coaxial cable filters equivalent to Microwave Filter Company Model 5KFM-89.5 will be obtained and installed free of charge as needed to remedy specific cases in properly installed TV receiver systems. CALVARY shall act in good faith to expeditiously assess and remedy bona fide problems of interference, but shall not be responsible for repairing or otherwise re-designing substandard receiver systems that cannot be solved by coaxial inline attenuation of undesirable 89.5 MHz energy.

6. Beginning from the date of transmission from the site, CALVARY shall advertise weekly for 16 weeks, in a Napa newspaper stating, "CALVARY CHAPEL OF TWIN FALLS is transmitting with a new transmitter in the Napa area on 89.5 MHz and may cause interference to KVIE, Channel 6 in Sacramento. If you are experiencing interference from CALVARY radio to KVIE Channel 6 call CALVARY at 1-800-357-4226 during normal business hours for interference relief."

7. Beginning from the date of transmission from the new site, CALVARY shall make two announcements a day, one of them during "prime-time" hours for a period of 16 weeks as follows:

"CALVARY CHAPEL OF TWIN FALLS is transmitting with a new transmitter in the NAPA area on 89.5 MHz and may cause interference to KVIE, Channel 6 in Sacramento. If you are experiencing interference from CALVARY radio to KVIE Channel 6 call CALVARY at 1-800-357-4226 during normal business hours for interference relief. If a reception problem related to CALVARY Radio transmission is verified by trained CALVARY CHAPEL radio personnel, a FM interference filter will be installed at no cost. CALVARY will only provide correction for properly installed antenna/receiver systems."

8. A copy of the daily logs containing announcements and copies of newspaper advertisements shall be mailed to KVIE, to the attention of Chief Operator, monthly, covering the time frame of the notice.

9. Violation of this agreement shall be grounds for FCC revocation of the CALVARY Napa, CA translator license, per Part 73.535 of FCC Rules and Regulations.
