Dear Applicant:

This is in reference to the above captioned request for Program Test Authority dated June 5, 2006 requesting reinstatement of the automatic program test provisions of 47 C.F.R. § 73.1620.

This request is filed pursuant to special operating conditions contained in KBPI's construction permit BXPB-20040511ABL. The conditions state that a formal request for program test authority must be filed prior to or in conjunction with FCC Form 302, Application for License, after the permittee has: (1) made proper radiofrequency ("RF") electromagnetic field strength measurements throughout the transmitter site area to determine if there are any areas that exceed the FCC specified guidelines for human exposure to RF fields; (2) made sufficient measurements to establish that KBPI complied with the spurious emissions requirements of 47 C.F.R. § 73.317(b) through 73.317(d); and (3) submitted a proof-of-performance from the directional antenna manufacturer, a statement from a licensed surveyor, and an affidavit from a qualified engineer. In the request, KBPI provides a RF study containing field measurements in the vicinity of the transmitter building and tower. KBPI concludes that the results of these measurements demonstrate compliance with the RF guidelines. In addition, KBPI provides a report dated April 29, 2005 containing measurements demonstrating compliance with 47 C.F.R. § 73.317. Finally, KBPI submitted the required exhibits demonstrating compliance with special operating conditions regarding the directional antenna.

Accordingly, we find that the special operating conditions contained in construction permit BXPB-20040511ABL have been satisfied and automatic program test authority IS HEREBY REINSTATED. Automatic program test authority may commence pursuant to 47 C.F.R. § 73.1620. Please include a copy of this letter when filing FCC Form 302-FM, Application for FM Broadcast Station License.
