Dear Licensee:

Townsquare Media Shreveport License, LLC is hereby notified of the modification of its license for KXKS-FM, Shreveport, LA, to specify operation on Channel 229C0.

On October 23, 2015, Bowen Broadcasting, Inc., licensee of a new station in Calhoun, LA, filed a new construction permit application. Bowen Broadcasting's application proposed that KXKS-FM's license be modified to specify Class C0 in lieu of Class C in accordance with the procedures set forth in Note 4 of 47 C.F.R. Section 73.3573.² Accordingly, by staff letter dated October 23, 2015, KXKS-FM was directed to show cause why its license should not be modified to specify Channel 229C0 in lieu of Channel 229C. The letter stated that failure to respond to this letter within thirty days will result in the automatic downgrade of KXKS-FM. As of the date of this letter, KXKS-FM has failed to file a response to the October 23, 2015 letter, and thus, has consented to the downgrade.

Accordingly, pursuant to the authority found in Sections 4(i), 5(c)(1), 303, and 307(b) of the Communications Act of 1934, as amended, and Sections 0.61, 0.204(b), 0.283, 1.420, 73.203(b), and 73.3573 of the Commission's Rules, as amended, IT IS ORDERED, that effective the date of this letter, the FM assignment IS MODIFIED, as follows:
