Dear Mr. Friemel:

This letter is in reference to: the above captioned minor change application filed by Raftt to modify the KYRO(AM) licensed facility by changing the antenna and city of license from Potosi, Missouri, to Troy, Missouri; and the June 28, 2010 amendment to change the daytime power and radiator height.

A preliminary review of the amended application reveals that the proposed nighttime facility will increase the 25% RSS limit to co-channel Class B station WWTC(AM), Minneapolis, Minnesota, in violation of Section 73.182 of the Commission's rules. Specifically, the WWTC(AM) 25% RSS exiting limit of 4.4 mV/m is comprised of the contributions 2.63 mV/m from KKAR(AM), 1.87 mV/m from WKBF(AM), 1.81 mV/m from KNWC(AM), 1.4 mV/m from ZYJ-455, 1.33 mV/m WODT(AM), and 1.29 mV/m from WIRL(AM). The proposed KYRO(AM) limit of 1.27 mV/m will increase the WWTC(AM) limit to 4.6 mV/m. In addition, the proposed KYRO(AM) daytime 0.5 mV/m and 0.025 mV/m contours will overlap the respective contours of co-channel station KDKD(AM), using M3 conductivity data, because the KDKD(AM) radials 26°, 45°, 65°, 85° were not amended to include additional close-in points, as requested in our June 19, 2010, deficiency letter.

Further action on the subject application will be withheld for thirty (30) days from the date of this letter to allow Raftt an opportunity to amend. Failure to amend or to file a request for additional time will result in the dismissal of the application pursuant to Section 73.3568 of the Commission's rules.
