

Figure 18.0 shows the service and interference contours for the proposed modified KOLU facilities in relation to those of all other domestic stations, both authorized and proposed, on Channels 208 through 214 that require protection consideration. All contours were projected using the notified facilities for each station from the FCC's Consolidated Database System ("CDBS") and terrain data extracted from the NGDC 30 second terrain database. As shown in this figure, the predicted 60 dBu contour for the proposed KOLU facilities will overlap the predicted 100 dBu contour for the facilities authorized by the construction permit (BNPED-20071018AQJ) for a new station on Channel 213C2 in Prosser, Washington.¹ A complete discussion of this overlap situation, as well as a request for an appropriate waiver, is included in Exhibit 17 to the attached application. Figure 18.0 shows that, with this exception, the proposed KOLU facilities will not cause or receive any prohibited contour overlap with any other station that requires protection consideration.

Table 18.0 shows the actual and required separations between the proposed modified KOLU facilities and all stations and allotments operating on Channels 264 and 265. As can be seen from this table, the proposed KOLU facilities have adequate separation from all facilities requiring consideration.

¹Similar prohibited overlap also exists with the facilities proposed in an application (BNPED-20071022BRO) for a new station on Channel 213C2 in Benton City, Washington. The Benton City application was dismissed on August 26, 2011, but the applicant filed a timely *Petition for Reconsideration* of the dismissal of this application.
