This request is submitted on behalf of Radio for Sale, LLC ("Radio for Sale"), permittee of FM translator station K223CI, Tucson, AZ (facility ID 141418), regarding the tolling of time for building the new station pursuant to its outstanding construction permit (BMPFT-20151019AAE).

This CP was granted subject to the following condition (copy attached):

*This application is being granted prior to the completion of the international notification process. Therefore, any construction of and operation with the facilities specified herein is at applicant's own risk and subject to modification, suspension or termination without right to hearing, if objected to by the Instituto Federal de Telecomunicaciones ("IFT") in Mexico or if found by the Commission or the IFT to be necessary in order to conform to the 1992 USA-Mexico FM Broadcasting Agreement. This condition will be removed if formal acceptance of the facilities granted herein is received from IFT.*

The applicant hereby requests tolling of the permit expiration due to lack of Mexican concurrence. The applicant requested a grant in advance of Mexican concurrence; however, it was expected that Mexican concurrence would have been granted by now.

- 2 Since the application proposes to mount its FM antenna above the co-located existing directional antenna of K269FV, Oro Valley, AZ, the permittee must submit, with the FCC Form 350, application for license, an exhibit including a statement from the manufacturer of K269FV's directional antenna stating that the proposed antenna will have no adverse effect on the K269FV directional antenna pattern.
- 3 Prior to commencing program test operations, FM Translator or FM Booster permittee must have on file at the Commission, FCC Form 350, Application for an FM Translator or FM Booster Station License, pursuant to 47 C.F.R. Section 74.14.

Special operating conditions or restrictions:

- 4 The permittee/licensee in coordination with other users of the site must reduce power or cease operation as necessary to protect persons having access to the site, tower or antenna from radiofrequency electromagnetic fields in excess of FCC guidelines.
