**I. Description of Transaction**

This and related applications (collectively, the “Divestiture Trust Applications”) request the Commission’s consent to the assignment of the stations identified on Appendix A hereto to The Entercom Divestiture Trust (the “Trust”). The trustee of the Trust is TDC Communications, LLC (the “Trustee”), whose sole member is Elliot Evers.

The proposed assignment to the Trust is incidental to a larger transaction, which is a merger of a subsidiary of Entercom Communications Corp. (“Entercom”) with and into CBS Radio Inc. (“CBS Radio”), which is currently a wholly owned indirect subsidiary of CBS Corporation (“CBS”). The merger will result in (i) the transfer of control of CBS Radio from National Amusements Inc., the controlling shareholder of CBS, to Entercom, and (ii) the transfer of control of Entercom from Joseph M. Field, who currently holds a majority of the voting power in Entercom, to the post-merger shareholders of Entercom generally, none of whom will have control (collectively, the “Transaction”).<sup>1</sup> For the Transaction to comply with the Commission’s local radio ownership rule, divestitures will be required in the following seven markets (the “Required Divestitures”):

In the event that any of the Required Divestitures have not been completed by the time scheduled for the closing of the Transaction, the parties propose to assign the Required Divestiture stations to the Trust. In certain markets, the parties are seeking consent to assign to the Trust more than the Required Divestiture stations in order to retain the flexibility to select the exact stations to be placed in Trust during the period between the filing of the Divestiture Trust Applications and the closing of the Transaction.<sup>2</sup> The parties understand that the Trust cannot have an attributable interest in all of these stations. By the time the parties are ready to close the Transaction, they will have decided which stations to assign to the Trust, and will put into the Trust no fewer than the 14 Required Divestiture stations (unless any such required divestiture has taken place at or prior to closing) and no more stations than are allowable under the Commission's local radio ownership rule. The parties will amend the Divestiture Trust Applications to specify the stations that will be assigned to the Trust.

## **II. Agreements**

All agreements relating to the Trust are, or will be, between Entercom and the Trustee. Copies of the agreements relating to the Trust, which include the Engagement and Assignment Agreement and the form of Trust Agreement, are attached at Exhibit 13 to this application. Exhibit B to the Engagement and Assignment Agreement has been omitted because it contains proprietary information that is not germane to the Commission's consideration of this application. As a result, Section II, Question 3 and Section III, Question 3 of this application have been answered "no."<sup>3</sup> Exhibit B will be provided to the Commission upon request, subject to the right of the parties to ask that the material submitted be held in confidence and not be made available for public inspection pursuant to applicable rules and policies of the Commission that restrict public access to confidential and proprietary information.

### III. Trust Structure

As described in further detail in the Comprehensive Exhibit, it is the Commission's longstanding precedent to permit divestiture trust arrangements in situations where a transaction involving multiple stations in multiple markets would result in a party exceeding the ownership caps in one or more markets.<sup>4</sup> Under this well-established Commission precedent, a beneficiary's ownership interest is not attributable to the beneficiary if it is properly insulated to prevent the exercise of control or influence over the trustee.<sup>5</sup> The Commission has set out certain standards for properly insulated trusts.<sup>6</sup>

The relationship between Entercom, the Trustee and the trust will be governed by the Engagement and Assignment Agreement dated as of March 17, 2017 between Entercom and the trustee, and by a Trust Agreement between Entercom and the Trustee to be entered into upon consummation of the Transactions. Those agreements provide, among other things, that the assets of the radio stations placed in trust to be divested as described above will be assigned to the Trust, and that the Trustee shall have the power to effect sales of those stations to third parties as soon as reasonably practicable and at the maximum price reasonably attainable, provided that Entercom may establish a minimum acceptable price for the stations. If Entercom enters into an agreement to sell any of those stations prior to closing of the Transactions and assignment of the stations to the Trust, the Trustee shall assume the obligations of Entercom under such agreement pending FCC and any other required governmental approvals. The Trust Agreement will further provide that the Trustee shall have complete control over the stations placed in the Trust and will operate them as separate, independent and active competitors to Entercom. While the stations are in trust, Entercom shall receive any net revenues from their operation in excess of actual and projected expenses as determined by the Trustee in its sole discretion.

Additionally, under the terms of the proposed Trust Agreement:

- Entercom cannot replace the Trustee at will;
- Entercom cannot revoke the Trust;

- The Trustee does not have a business, personal or extra-trust relationship with Entercom, its affiliates or any of the shareholders, directors, officers or employees of Entercom or its affiliates (collectively “Related Parties”);<sup>7</sup> and
- Neither Entercom nor any Related Party may communicate with the Trustee concerning the management and operation of the stations assigned to the Trust, except to deliver financial reports or to facilitate the sale of the stations to an unaffiliated third party, and then any permitted communication must be evidenced in writing and retained for inspection by the Trust upon Commission request.

Accordingly, the proposed trust conforms to the Commission’s attribution insulation standards. By complying with the Commission’s attribution insulation standards, the Trust is properly insulated from Entercom’s influence in accordance with Commission precedent. In fact, the Trust Agreement is identical in all material respects to prior trust agreements that the Commission has recently approved.<sup>8</sup>

#### **IV. Entercom Character Disclosure**

Since 2005, Edward Stolz (“Stolz”) has filed objections to the qualifications of Entercom in connection with pending license renewal applications for stations owned by Entercom. In separate decisions released March 4, 2008 (DA 08-495), September 6, 2012 (1800B3-MM), October 14, 2014 (1800B3-JWF/AJR), March 18, 2015 (1800B3-SS), October 27, 2016 (FCC 16-141) and January 18, 2017 (1800B3-JM), the FCC has denied or dismissed these objections and granted multiple renewal applications for stations owned by Entercom. On February 22, 2017, Stolz filed a Petition for Reconsideration against the Commission’s January 18, 2017 decision and that matter remains pending.

In connection with the 2013 renewal application for station KDND(FM) (Facility ID No. 65483) in Sacramento, CA, the Media Action Center in El Dorado Hills and Sue Wilson (collectively, “MAC”) filed a Petition to Deny the renewal application, raising a claim that Entercom License, LLC (“Entercom License”), a subsidiary of Entercom, lacks the character qualifications to be an FCC licensee. Stolz raised similar character issues in a reply pleading filed December 23, 2013.

On October 27, 2016, the FCC released a Hearing Designation Order and Notice of Opportunity for Hearing (“HDO”) (FCC 16-153), setting the July 28, 2005 and July 30, 2013 KDND license renewal applications for hearing on issues relating to whether Entercom License

operated KDND in the public interest. In the HDO (at note 122), the Commission declined to designate for hearing any character qualification issues. On January 9, 2017, in response to the HDO, MAC filed a Petition to Enlarge Issues, requesting that the hearing address issues related to Entercom’s character qualifications to remain a Commission licensee.

On February 8, 2017, KDND permanently ceased operation and surrendered its license to the FCC. On the same date, Entercom License filed a Motion to Dismiss the pending KDND renewal applications and terminate the hearing. MAC opposed the Motion on February 10, 2017 and Stolz filed comments and renewed his prior arguments.

On February 22, 2017, Entercom and MAC filed a Joint Motion for Approval of Settlement Agreement Pursuant to Section 73.3588. Pursuant to the Settlement Agreement, MAC agreed to dismiss with prejudice its Petition to Deny and Petition to Enlarge. On March 16, 2017, the Administrative Law Judge issued an Order granting the Joint Motion for Approval of Settlement and Entercom’s Motion to Dismiss, and terminated the HDO proceeding.

**VII. Compliance with Local Radio Ownership Rule**

The Divestiture Trust Applications implicate the local radio ownership rule. As shown below, the Trust will comply with the local radio ownership rule upon consummation of the Divestiture Trust Applications.

Section 73.3555(a)(1)(i) of the Commission’s rules limits the number of stations in which a person or entity may have a cognizable interest in a particular market. The rule further caps how many same service stations (i.e., AM or FM) a person or entity may hold in that market. The market caps and same service sub-caps set forth in Section 73.3555(a)(1)(i) are as follows:

Below is a market-by-market analysis of the broadcast interests that will be held by the Trust upon consummation of the Divestiture Trust Applications.<sup>9</sup> Appendix E hereto contains copies of the BIA Kelsey FCC Geographic Market Definition reports for each of these markets.

- Boston, MA

As shown on the attached BIA Kelsey Media Access Pro FCC Geographic Market Definition Reports, there are 45 or more commercial and noncommercial radio stations in the Boston, MA Nielsen Audio Market. Therefore, common ownership of eight radio stations, no more than five in the same service, is permitted. Upon consummation of the Divestiture Trust Applications, the Trust will have an attributable interest in no more than eight radio stations (no more than five in the same service), which is permitted under the local radio ownership rule.

- Los Angeles, CA

As shown on the attached BIA Kelsey Media Access Pro FCC Geographic Market Definition Reports, there are 45 or more commercial and noncommercial radio stations in the

Los Angeles, CA Nielsen Audio Market. Therefore, common ownership of eight radio stations, no more than five in the same service, is permitted. Upon consummation of the Divestiture Trust Applications, the Trust will have an attributable interest in no more than two FM stations, which is permitted under the local radio ownership rule.

- Sacramento, CA

As shown on the attached BIA Kelsey Media Access Pro FCC Geographic Market Definition Reports, there are 45 or more commercial and noncommercial radio stations in the Sacramento, CA Nielsen Audio Market. Therefore, common ownership of eight radio stations, no more than five in the same service, is permitted. Upon consummation of the Divestiture Trust Applications, the Trust will have an attributable interest in no more than eight radio stations (no more than five in the same service), which is permitted under the local radio ownership rule.

- San Diego, CA

As shown on the attached BIA Kelsey Media Access Pro FCC Geographic Market Definition Reports, there are 45 or more commercial and noncommercial radio stations in the San Diego, CA Nielsen Audio Market. Therefore, common ownership of eight radio stations, no more than five in the same service, is permitted. Upon consummation of the Divestiture Trust Applications, the Trust will have an attributable interest in one FM station, which is permitted under the local radio ownership rule.

- San Francisco, CA

As shown on the attached BIA Kelsey Media Access Pro FCC Geographic Market Definition Reports, there are 45 or more commercial and noncommercial radio stations in the San Francisco, CA Nielsen Audio Market. Therefore, common ownership of eight radio stations, no more than five in the same service, is permitted. Upon consummation of the Divestiture Trust Applications, the Trust will have an attributable interest in no more than eight radio stations (no more than five in the same service), which is permitted under the local radio ownership rule.

- Seattle-Tacoma, WA

As shown on the attached BIA Kelsey Media Access Pro FCC Geographic Market Definition Reports, there are 45 or more commercial and noncommercial radio stations in the Seattle-Tacoma, WA Nielsen Audio Market. Therefore, common ownership of eight radio stations, no more than five in the same service, is permitted. Upon consummation of the Divestiture Trust Applications, the Trust will have an attributable interest in no more than eight radio stations (no more than five in the same service), which is permitted under the local radio ownership rule.

- Wilkes Barre-Scranton, PA

As shown on the attached BIA Kelsey Media Access Pro FCC Geographic Market Definition Reports, there are 45 or more commercial and noncommercial radio stations in the

Wilkes Barre-Scranton, PA Nielsen Audio Market. Therefore, common ownership of eight radio stations, no more than five in the same service, is permitted. Upon consummation of the Divestiture Trust Applications, the Trust will have an attributable interest in one FM station, which is permitted under the local radio ownership rule.
