**PETITIONERS MOTION TO REQUEST TO EXTEND TIME FOR REPLY BRIEF**


Petitioner, acting on his own behalf, hereby motions this body to grant a thirty day (30) extension of time to file his reply to Applicant's Opposition pursuant to Title 47 of the Federal Code of Regulations Chapter 1, Subchapter A, Part 1, Subpart A, Subgroup A, Section 1.46.

Petitioner filed his initial Petition on October 31, 2014. According to 47 C.F.R. Section 3584(b), Applicant had 30 days to file an opposition. Since November 30, 2014 was a Sunday, Applicant filed its opposition on December 1, 2014. Pursuant to 47 C.F.R. Section 3584(b), Petitioner's reply is due on or before 20 days after the date Applicant's opposition is filed, whichever is longer. Since Petition had until December 20<sup>th</sup> to file its opposition, a Saturday, Petitioner had at least until Monday December 22, 2014 to file its reply.

According to the Opposition Brief of Applicant, it was filed on December 1, 2014. However, Petitioner Harjo finally received the Opposition Brief via certified US mail on December 15, 2014. Accordingly, Petitioner had only had seven full days to review and respond to the Opposition Brief. This amount of time is insufficient to adequately respond to the arguments made by Applicant.

Petitioner also requests this body to consolidate the Petitions of Larry Smith and Jennifer Verenchik and his Motion for Extension of Time. All Petitioners are acting on their own behalf.


