Introduction

Hoffman Schutz Media Capital ("HSMC") has been retained by Goldman, Sachs & Co., Inc. to conduct a Contour Study, pursuant to Part 73.3555 of the FCC's ownership regulations. Four FM broadcast radio stations are the subject of consideration in this study. These stations are listed below:

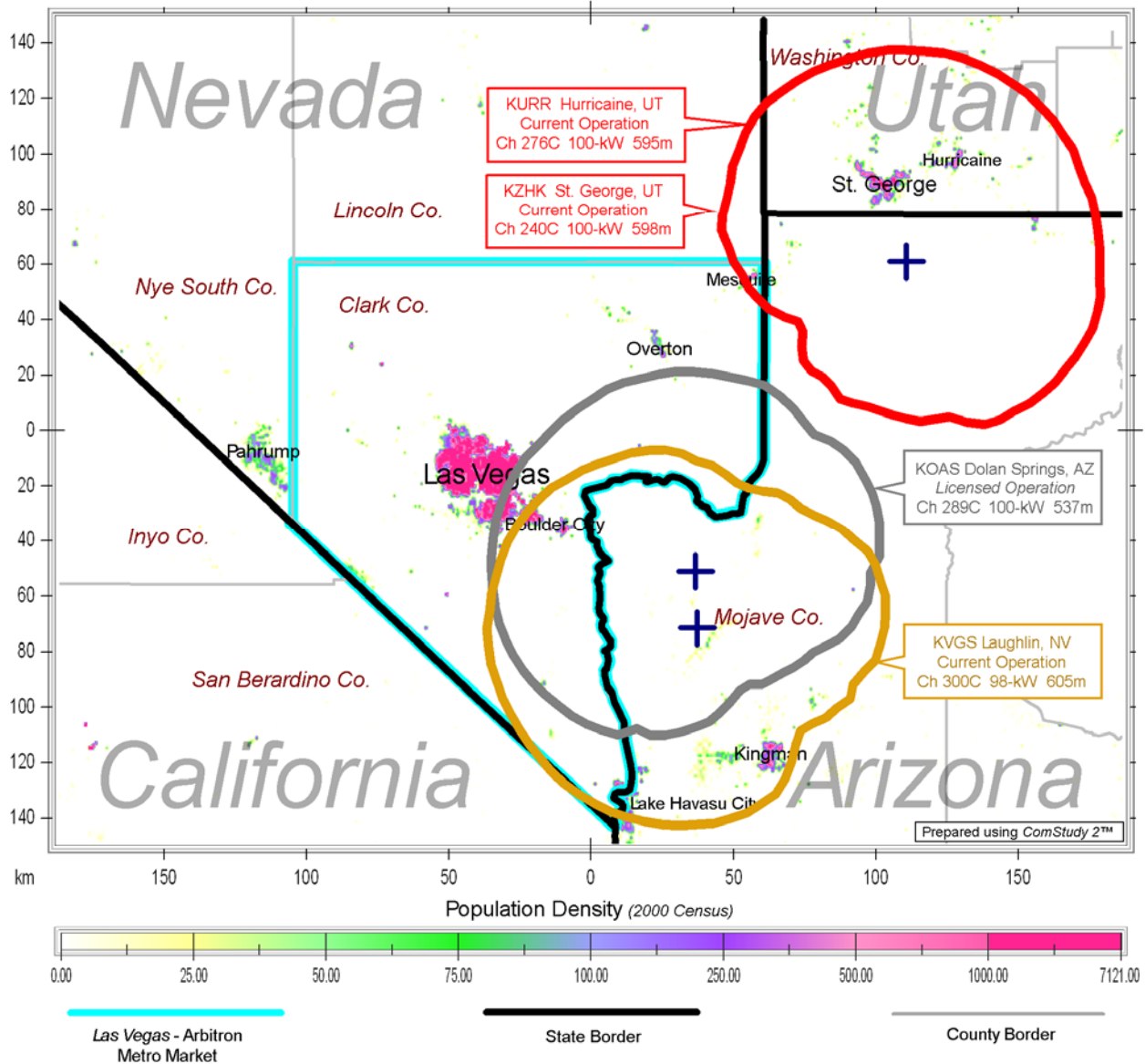

Note: KVGs is authorized to relocate, and share a common antenna with KOAS. The two stations will have identical contours.

All four of the subject stations are currently operating, but the Construction Permits of three of them will change the nature of the City Grade (3.16 mv/m) contour overlap between them. At the present time, the contours of these four stations create two separate overlaps areas, as shown on Figure 1. In the northern portion of the figure, KZHK and KURR have almost complete overlap, resulting from virtually identical signal contours. To the south, KOAS and KVGs have substantial overlap. Under the terms of the Construction Permits, the overlap of KOAS and KVGs will rise to 100%, as the stations commence use of a common antenna (Figure 2). At the same time, the Construction Permit of KZHK will create overlap from this station with KOAS and KVGs.

KZHK holds a Construction Permit to change its community of license to Bunkerville, NV. KURR holds a construction permit to change its community of license to Indian Springs, NV. Figure 2 shows the City Grade contours for these stations following completion of these changes. It illustrates how the changes will result in the elimination of contour overlap between KZHK and KURR. It also shows how KURR will no longer have any overlap to any of the other subject stations.

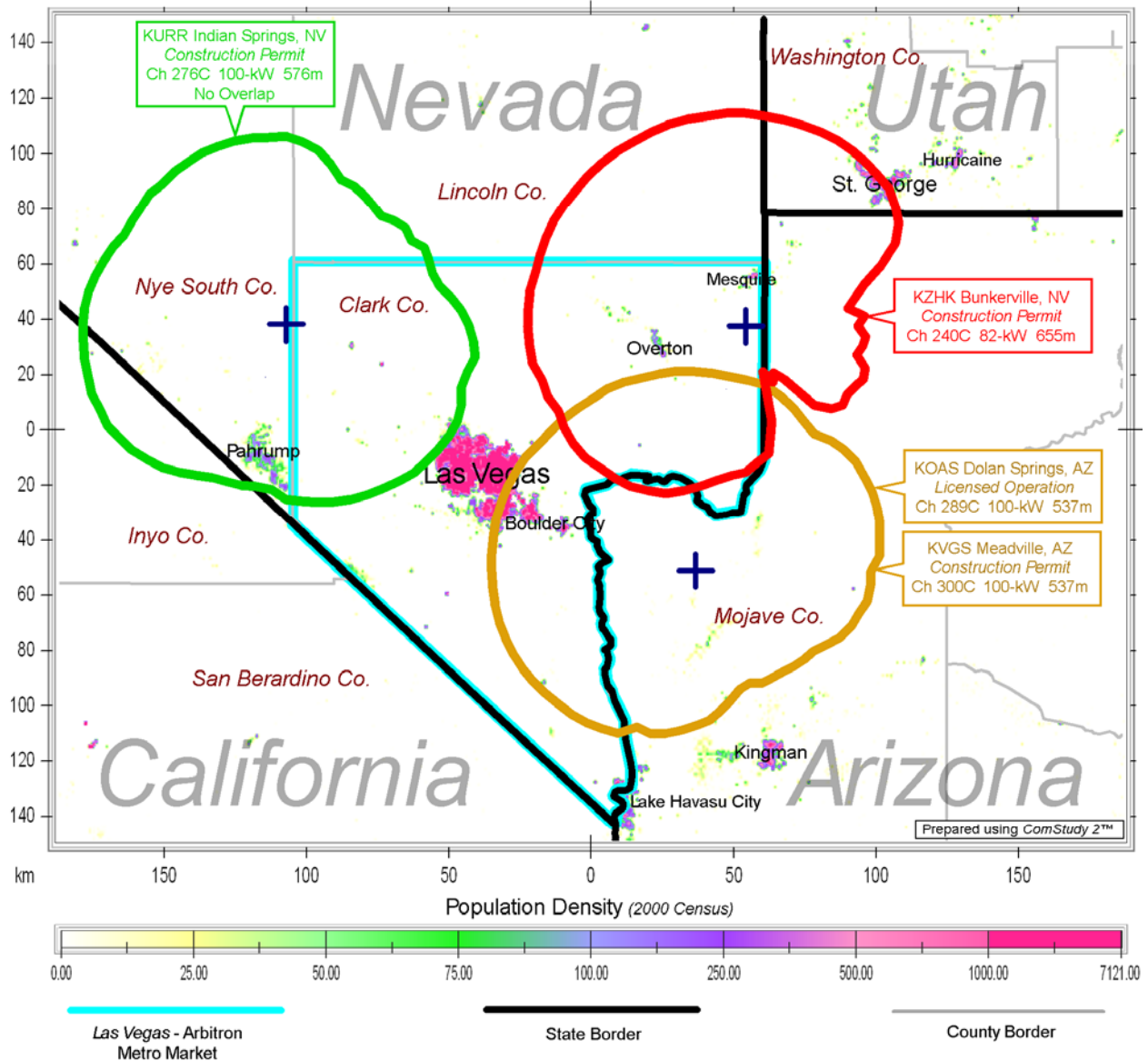
To the south, KVGS holds a construction permit to change its community of license to Meadville, AZ. This will result in the relocation of its transmitter to a location where it will share a common antenna with KOAS. This will also result in the creation of identical contours for those two stations.

The relocation of KVGS, Meadville, AZ, and KZHK, Bunkerville, NV, will create a change in the overlap area at the intersection of the KOAS, KVGS, and KZHK City Grade contours. The predicted contours of these stations appear in Figure 2 on the following page.

Virtually all of the overlap area between the three stations is situated within the *Las Vegas Arbitron Metro* market, currently the nation's 33rd largest market, on the basis of population. The specific area of overlap is very sparsely populated and contains fewer than 1,000 people. For the purpose of this study, the overlap area will be treated as an autonomous *Instant Market*.¹

¹ Regarding the two markets on Figure 1 (the KURR/KZHK market and the KOAS/KVGS market), 10 of the 37 signals listed on page 6, cover both of the two market areas that exist today.

Available Radio Signals.

The City Grade Contours of numerous other radio stations intercede into the area forming the *Instant Market*, which is the subject of the study. Aside from the signals of the three FM stations forming the primary overlap, the City Grade Contours of 23 additional commercial and noncommercial FM radio signals extend into varying portions of the Instant Market. Additionally, the 5-mv/m daytime, City Grade Contours of the 11 broadcast AM radio stations are available in the Instant Market. This brings the grand total of signals available to 37, including the three FM stations, which are the primary impetus for this study.

The table on the following page provides the identities and related operating information for the stations with City Grade contours that encompass the Instant Market formed by KOAS, KVGs, and KZHK.
