Dear Mr. Villarreal:

This is in reference to the above-captioned application and to your request to operate with program test authority for station KRCM(AM).

Authority is granted KRCM(AM) to conduct daytime and nighttime program tests in accordance with construction permit BP-20120110AEV and Section 73.1620 of the Commission's rules to operate on 1380 kHz with a daytime nominal power of 22.0 kilowatts and a nighttime nominal power of 50 watts. Program tests are authorized with a daytime input power of 23.17 kilowatts (antenna common point current of 20.9 amperes) and a nighttime input power of 54 watts (antenna common point current of 1.01 amperes).

Daytime and Nighttime operating parameters for tower #1, #2 and #3 are as follows:

Antenna sample current ratios: 0.515, 1.0, and 0.558  
Antenna monitor phases: -74.9°, 0.0° and 74.9°

The following deficiencies were found with the application:

<sup>1</sup> Please note that grant of this license application is conditioned on continuous operations of the licensed facility for the twelve-month period following grant. Failure to do so will result in the rescission of this grant, dismissal of the license application and the forfeiture of the associated construction permit pursuant to 47 C.F.R. § 73.3598(c) unless licensee rebuts presumption that authorized facilities were temporarily constructed.

1. The daytime operating current must be amended to 20.9 amperes on page 4 of the FCC Form 302 and Exhibit 9.
2. The make of the sample line must be provided.
3. Reference measurements were not made on the pattern maxima in violation of Section 73.151(c)(3).
4. The date and time of the reference measurements were not provided.
5. The reference measurements must be made at the correct daytime power of 23.17 kilowatt (not 24.5 kilowatt).
6. Please confirm that the nighttime measurements were made at 54 watts.

Further action on the license application and the program test authorization will be withheld for thirty (30) days from the date of this letter in order to provide you time to file an amendment. Failure to respond or file an amendment within this time period may result in the dismissal of the license application and cessation of program tests pursuant to Section 73.3568 of the rules.
