

The instant application seeks Commission consent for a minor modification of the technical facility of KASH-FM Anchorage, Alaska, which is licensed to a wholly-owned subsidiary of Clear Channel Communications, Inc. (“Clear Channel”). This amendment is being provided to demonstrate compliance with the Commission’s modified broadcast ownership rules, as set forth in the Commission’s *Report and Order and Notice of Proposed Rulemaking*, FCC 03-127, issued in MB Docket 02-277 (released July 2, 2003) (“*Report and Order*”).

In addition to the station to be modified (KASH-FM), Clear Channel also controls the licensees of KENI(AM), KTZN(AM), KBFX(FM), KGOT(FM), and KYMG(FM). All of these Clear Channel controlled stations, as well as KASH-FM, are licensed to Anchorage, which is a community that is “home” to the Anchorage, Alaska Arbitron Metro Survey Area (“Arbitron Metro”) (Arbitron Metro No. 175). Except for the foregoing radio stations, the applicant hereby certifies that Clear Channel and its subsidiaries have no attributable interest in, nor have any joint sales agreement (“JSA”) with, any radio station that is “home” to or licensed to the Anchorage, Alaska Arbitron Metro. Moreover, the station subject to this application has a community of license that is within the geographic boundaries of the Anchorage, Alaska Arbitron metro. Consequently, under the Commission’s FCC 301 worksheet No. 2 item 4 “Interim Contour – overlap Methodology”, no contour overlap analysis is required in regards to the local radio ownership rule.

Attached hereto is a list of all commercial and non-commercial full-power radio stations that: (1) are listed in BIA’s Media Access Pro database as being “home” to the Anchorage, Alaska Arbitron Metro; or (2) are licensed to communities within the Anchorage, Alaska Arbitron Metro. As shown, there are 30 stations in the relevant local radio market under the counting methodology set forth in the Commission’s *Report and Order*. Clear Channel may

therefore have an attributable interest in up to seven radio stations, no more of four of which may be in the same service. *See* 47 C.F.R. Section 73.355(a)(1). Consequently, as calculated pursuant to the Commission's *Report and Order*, Clear Channel's control of four FM and two AM stations in the local radio market here complies with the local radio ownership rule.

KASH-FM's community of license, Anchorage, is located in the Anchorage, Alaska Nielsen television Designated Market Area ("DMA") (DMA No. 155). The applicant hereby certifies that Clear Channel and its subsidiaries have no attributable interest in, nor have any joint sales agreement ("JSA") with, any television station licensed to the Anchorage, Alaska DMA. Moreover, the applicant hereby certifies that Clear Channel and its subsidiaries have no attributable interest in any daily newspaper of general circulation published in the United States. Consequently, the new "cross-media limits" set forth in the Commission's *Report and Order* are not implicated by this application.
