

Changes in Ownership Interests

The transaction involves the pro forma assignment of WCRB, Lowell, Massachusetts (the "Station") from Nassau Broadcasting III, L.L.C. ("Nassau 3") to Nassau Broadcasting II, L.L.C. ("Nassau 2"). Control will be exercised both before and after consummation by Louis F. Mercatanti, Jr. Nassau 2 and Nassau 3 are "sister" companies that have identical direct and indirect ownership structures. Therefore, attributable ownership before the pro forma assignment of license has been omitted for Nassau 3, but has been included below in its entirety for Nassau 2. **At the consummation of the assignment after receipt of Commission approval, the ultimate attributable ownership in the Station's license will be exactly the same as now.**

The ultimate owner of the assignee is Nassau Broadcasting Partners Limited Partnership ("Nassau Partners") (see Table 3 below). The sole limited partner of that company is Nassau Partner Holdings, L.L.C. (see Table 11 below).

Louis F. Mercatanti, Jr. is the individual who controls Nassau 2. Mr. Mercatanti controls Nassau 2 through his 59.99% equity and voting control of Nassau Partners, through the ownership and voting control of NBP, Inc., the sole general partner of Nassau Partners, as set forth in items 4 and 5 below. NBP, Inc. has the only voting rights in Nassau Partners.

In addition to his direct ownership and voting control of the general partner of Nassau Partners, Mr. Mercatanti has significant indirect ownership through his indirect ownership in the limited partner of Nassau Partners, Nassau Partner Holdings, L.L.C., as set forth in item 11 below. Mr. Mercatanti is the largest equity owner of Nassau Management, L.L.C. ("Management"), which holds a 60.73% equity ownership interest in the limited partner of Nassau Partners. Mr. Mercatanti owns 94.5% of that 60.73% of Management. (See Item 12 below).

Thus, Mr. Mercatanti will control 59.99% of the total voting control over Nassau 2 and have direct and indirect ownership interests in Nassau 2 of approximately 57% of the total equity ownership interests in Nassau 2.

Certain parties who have been identified in Table 11 below and who hold collectively less than 5% of the voting and ownership of Nassau Partner Holdings, L.L.C. are nonattributable owners. Nassau 3 has disclosed the identity of these parties out of an abundance of caution but confirms that they hold non-attributable ownership interests.
