RE: Permission to use the full power DTV emission mask to protect BLCDT-20041117AAB and BPCDT-20080905AAC for KJLA, Channel 49, Venture, CA, Facility ID 14000

Dear Licensee of KJLA:

Venture Technologies Group, LLC ("VTG") is the licensee of KNLA-LD, Channel 50, Los Angeles, CA, Facility ID 167309. VTG plans to propose a minor change to its licensed facility BLDTL-20110617ACW using the full power DTV emission mask pursuant to *Heading J (Use of Full Power DTV Emission Mask), Paragraph 68 of the Second Report and Order In the Matter of Amendment of Parts 73 and 74 of the Commission's Rules to Establish Rules for Digital Low Power Television, Television Translator, and Television Booster Stations and to Amend Rules for Digital Class A Television Stations*, MB Docket No. 03-185, released and adopted on July 15, 2011. Under the new rules, permission from KXLA will not be required for the use of the full power DTV emission mask. However, these rules are not yet in effect and will not be until after they are published in the Federal Register. Therefore, VTG hereby requests you to provide permission to KNLA-LD to use the full power DTV mask filter.

The use of the full power DTV emission mask adds greater protection to the facilities of KJLA. The Techware's tv_process_2010 software, on a Sun Blade 1500 using the post transition data and the 2000 US Census with default analysis settings, predicts when using the full power DTV emission mask, the proposed facility of KNLA-LD only causes "*de minimis*" interference (less than 0.5%) to the facilities of KJLA, Channel 49, Venture, CA, Facility ID 14000 as specified in BLCDT-20041117AAB and BPCDT-20080905AAC.

In the event that the proposed facility of KNLA-LD is found to cause more than "*de minimis*" interference to the abovementioned facilities of KJLA; VTG will immediately take necessary actions to eliminate such interference.
