
Dear Applicant:

This is in reference to the above application and the request for an additional extension of the construction permit period received on November 27, 2017. For the reasons stated below, the request for an additional extension will be denied.

Section 73.3598 of the Commission's Rules¹ allow extension of an original LPFM construction permit for an additional 18 months. The permit was extended on April 01, 2016. No subsequent or additional extensions are provided for. Tolling of the construction permit deadline can be requested under certain specific conditions that prevent construction due to causes not under control of the permittee. These causes include acts of God (such as floods, tornados, hurricanes, or earthquakes), administrative and judicial challenges to the permit's grant, or a pending request for international coordination. Tolling requests should be submitted 30 days before the permit's expiration.

Accordingly, in light of the above, the request for an additional extension of the construction permit period for BNPL-20131113BUD as modified by BMPL-20170410AAQ IS HEREBY DENIED. These actions are taken pursuant to 47 C.F.R. § 0.283.

Pursuant to 47 C.F.R. § 73.3512 of the Commission's rules, Toledo Integrated Media Education (BNPL-20131113BUD) seeks an 18-month extension of its original construction permit granted on December 9, 2014.

We have acquired all necessary equipment and funding to begin broadcasting, and are only awaiting the acceptance of a building permit from our city. This has taken longer than expected to engineer and file, leading us into a winter season that will make construction difficult, particularly for things like laying down concrete pads. Ideally, this construction would take place during warmer seasons in order to ensure the best possible stability at our site.

Therefore, we respectfully request an extension to the Construction Permit of an additional 12 months.
