Changes in Interests as a Result of Transfer

Aurora of Westchester License Company, LLC; Aurora of Bridgeport License Company, LLC; Aurora of Danbury License Company, LLC; and Aurora of Poughkeepsie License Company, LLC, are wholly-owned subsidiaries of Aurora Holding, LLC, which, in turn, is a wholly-owned subsidiary of Aurora Communications, LLC. Voting control of Aurora Communications, LLC, rests with Aurora Management, Inc., by virtue of its holding a 72.69% voting interest in Aurora Communications, LLC, and by virtue of the fact that the operating agreement of Aurora Communications, LLC, specifically provides that management, operation and control of Aurora Communications, LLC, is vested in Aurora Management, Inc.

Pursuant to an Acquisition Agreement dated as of November 18, 2001, the members of Aurora Communications, LLC, have agreed to sell, upon receipt of the requisite FCC approval, their membership interests in Aurora Communications, LLC, to Cumulus Media Inc. and its subsidiaries. Upon consummation of this transaction, the following changes in the interests held in Aurora Communications, LLC, will occur:
