

Description of Transaction

Texas Public Radio (“TPR”), licensee of noncommercial educational stations KPAC(FM), San Antonio, Texas; KSTX(FM), San Antonio, TX; and KTXI(FM), Ingram, Texas, is a non-stock, non-profit organization. TPR is filing this application to obtain Commission consent to a change in control of its Board of Directors that has gradually occurred, as the result of routine changes in the Board membership, in the more than two years since the Commission granted TPR’s last transfer of control application (BTCED-20061114ACT), in 2006. The changes in TPR’s Board have taken place pursuant to its Articles of Incorporation and By-Laws. New Board members are elected by TPR’s Board of Directors.
