APPLICATION FOR CONSTRUCTION PERMIT

The following engineering statement and attached exhibits have been prepared for **Pollack Broadcasting Co.** ("Pollack"), licensee of AM broadcast station KBOA at Kennett, Missouri, and are in support of their application for construction permit.¹ This application seeks to relocate the facility from its current site, to the site of the KBOA studio at Kennett, Missouri.

KBOA is currently authorized to operate on 1540 kHz as a class D facility. The present license authorizes non-directional operation with power levels of 1.0 kW during daytime, 0.5 kW during critical hours, and 1 Watt during nighttime hours. The relocated facilities proposed under this application would continue operation with a non-directional antenna. At the proposed new site, the proposed antenna input power levels are 1.0 kW daytime, 0.53 kW critical hours, and 0.003 kW nighttime.

The proposed facility, including its relocation, results in a reduction of contour overlap with other facilities during both daytime and critical hours. During nighttime, no interference in contravention of the applicable sections of the Commission's Rules would occur.

The proposed facility would utilize a new tower to be constructed at the KBOA studios. Previously the KBOA studio location was the site for another AM station that relocated. The proposed structure will have an overall height of 111 feet above ground, including the base pier and insulator, which will not require registration or FAA notification based on calculations performed through the Commission's *TOWAIR* utility.

Item 7 on the engineering portion (Section III-A) of FCC Form 301 lists a number of specific rule sections. The proposed facility would be in compliance with the following applicable sections of the Commission's Rules:

Section 73.24(e) - The technical equipment proposed, transmitter location, and other technical phases of operation will comply with the regulations governing the same, and the requirements of good engineering practice.

Section 73.24(g) - The resident population within the proposed 1 V/m service contour for each of the three hours of operation is zero persons. Since the resident population of each contour is less than 300 persons, this particular section is not applicable.

Section 73.33 - This application specifies a definite site for use by the facility. As was previously discussed, the proposed facility would utilize a non-directional antenna. All data necessary to show compliance with the terms of the construction permit will be submitted with the license application. Since the proposed facility would utilize a non-directional antenna, a proof of performance will not be required.

Section 73.45 - The proposed facility would comply with this section of the Commission's Rules. The proposed antenna system complies with the efficiency requirements for the class of station. The proposed facility will comply with the other portions of this section as applicable.

Section 73.150 - This section of the Commission's Rules is not applicable as the proposed facility would utilize a non-directional antenna.

Section 73.152 - This section of the Commission's Rules is not applicable as the proposed facility would utilize a non-directional antenna.

Section 73.160 - The proposed facility complies with this section of the Commission's Rules. The vertical plane radiation characteristics of the directional antenna were calculated according to the content of this section.

Section 73.182(a)-(i) - The proposed facility would comply with these sections of the Commission's Rules.

Section 73.186 - The proposed facility would utilize a non-directional antenna. Therefore, it is not expected that the actual inverse field value will need to be established. Should establishment of the field be required, the procedure will comply with that section of the Commission's Rules.

Section 73.189 - The proposed facility meets the minimum efficiency requirements for the class of operation.

Section 73.1650 - The proposed facility would comply with the applicable international agreements listed under this section.

The proposed facility complies with the community coverage requirements of Section 73.24(i) of the Commission's Rules. Exhibit E-1 illustrates the predicted 5 mV/m groundwave contour based on M-3 conductivity for both the daytime and critical hours modes of operation. This map demonstrates that the 5 mV/m contour would fully encompass Kennett during both daytime and critical hours modes. Since KBOA would continue to operate as a class D facility, no community coverage requirement during nighttime hours exists.

Exhibits E-2 through E-5 are maps depicting the remainder of the service contours for the proposed and licensed facility. Specifically included in these maps are depictions of the 5, 2 and 0.5 mV/m contours daytime, 5 and 0.5 mV/m contours critical hours, and the nighttime interference-free contours.² Both the currently licensed and proposed versions of the contours are depicted.

The main studio for KBOA complies with the provisions of Section 73.1125 of the Commission's Rules. The main studio is co-located with the transmitter. As a result, the main studio would necessarily be located within the 5 mV/m daytime service contour. Additionally, the main studio is located within twenty-five miles of the reference coordinates of Kennett, Missouri.

Exhibit E-6 is a site location map for the proposed facility. The proposed location for KBOA is denoted by a red triangle. This location is within the north central 2.5-minute portion of the Kennett South 7.5 minute topographic map.

Exhibit E-7 illustrates the proposed 1000 mV/m service contours for the daytime, critical hours, and nighttime operations. On this image, blue represents the daytime operation, while green is for critical hours. The red contour depicts the nighttime 1000 mV/m contour.

Exhibits E-8 and E-9 provide an overview of the daytime allocation situation for the proposed facility pursuant to the provisions of Section 73.37 of the Commission's Rules. In Exhibit E-8, a map illustrating the overlap situation is provided, with the relevant tabulation appearing in Exhibit E-9. As these two exhibits demonstrate, the proposed facility would have normally prohibited contour overlap with KAPE at Cape Girardeau, Missouri.³ This contour overlap, however, currently exists between the two facilities, and the area of the overlap would be reduced by the proposed relocation of KBOA. Exhibit E-10 illustrates the area in which reduction of contour overlap would occur.

A similar group of exhibits has been created for the critical hours operation of KBOA. Exhibits E-11 and E-12 provide the overview map and summary tabulation. The critical hours authorizations for relevant stations in the region were created using critical hours authorizations if available. Exhibit E-13 demonstrates that, as was the case with the daytime hours of operation,

the proposed critical hours facility would reduce the existing overlap area with KAPE at Cape Girardeau, Missouri.

In Exhibits E-14 and E-15, the contour distances for the daytime and critical hours allocation studies are tabulated. These tabulations also include the M-3 values of ground conductivity for the basis of the depicted contours. The ground conductivity values are tabulated in Exhibit E-16.

KOBA operates on 1540 kHz, which is a clear channel frequency shared by KXEL in Waterloo, Iowa, and ZNS-1 in the Bahamas.⁴ Due to the low power of operation, and distance separation, there is no calculated impact to ZNS-1 from the proposed KBOA facility. The nighttime situation to KXEL is illustrated in Exhibit E-17. The full tabular nighttime interference study to all other facilities is contained in Exhibit E-18.

Exhibit E-19 provides a critical hours allocation study for the proposed KBOA facility. This study pertains only to KXEL, as that is the only facility that requires consideration. This study demonstrates that the proposed facility complies with the relevant sections of the Commission's Rules, and is not predicted to cause interference to KXEL during critical hours.

The final graphical illustration for the facility is a site plat depiction in Exhibit E-20. This drawing illustrates the location of the tower and ground system, as well as other relevant structures at the site. Access to the site is obtained through one of the two access roads, that intersect Southwest Drive, or State Route O, on the east side of the site.

The proposed facility would not result in a significant environmental impact, and is exempt from environmental processing. The proposed structure does not require registration. Additionally, the structure would not involve a site location specified in Section 1.307(a)(1)-(7) of the Commission's Rules, and would not constitute an RF exposure hazard to persons in the vicinity. This site was formerly utilized as the site for an AM station that was relocated.

A fence is to be erected around the base of the tower. This fence is of a construction that will preclude and prevent causal exposure to the structure. At its closest point to the tower, the fence will have a radius of at least three (3) meters. This is of sufficient distance to comply with the distance recommendations in Appendix A of *OET Bulletin 65*. Additionally, Pollack will coordinate with all other users of the site to ensure that workers and other personnel are not exposed to levels of radiofrequency radiation in excess of the applicable safety standards. Such coordination will include, but is not necessarily limited to, a reduction in transmitter power or cessation of operation.

The proposed relocation of KBOA would be in compliance with the multiple ownership provisions of Section 73.3555 of the Commission's Rules. Exhibit E-21 provides an illustration of the multiple ownership situation. KBOA is a constituent station in two of the contour markets created by the Pollack stations. These two markets are indicated on this map.

Exhibit E-22 provides an analysis of the first market. This market is created by the common overlap between Pollack stations of KBOA-FM, KTMO, and the proposed facilities for KBOA. This market is created by the overlap between two FM stations and one AM station. It is therefore necessary and sufficient to demonstrate that Pollack would not control greater than fifty percent of

the stations serving the market. This map demonstrates that at least four other stations have contour overlap with the market subject to the procedures of the contour market methodology. The following table summarizes the facilities considered.⁵


Exhibit E-23 provides an analysis of the second market. This market is created by the common overlap between KTMO, KCRV, and the proposed KBOA facilities. This market comprised of two AM stations, and one FM station. As was the case with the first market, it is necessary and sufficient to demonstrate that Pollack would not control greater than fifty percent of the stations in the market. This map demonstrates that at least four other facilities have been identified that have contour overlap with the market. The following table summarizes the facilities considered.⁶




Exhibit E-6 - Site Location Map






Exhibit E-7 - Satellite Imagery of Proposed 1000 mV/m Contours (See Text)








Exhibit E-14 - Daytime Allocation Contour Distances
