This application seeks the Commission's consent to the assignments of the radio station combinations listed below from Monterey Licenses, LLC ("Assignor") to L&L Broadcasting LLC ("L&L"):

I. Peoria, IL

Each of the stations listed above is geographically located in and "home" to the Peoria, IL Arbitron Metro. Accordingly, demonstrating compliance with the Commission's radio multiple ownership restrictions requires only an analysis based on a count of radio stations in the Peoria, IL Metro.

As demonstrated in the attached BIA printout (Attachment A), the Peoria, IL Metro contains 23 full power radio stations. In markets with between 15 and 29 full power radio stations, Section 73.3555(a) of the Commission's rules allows common control of up to six radio stations, not more than four of which are in the same service.

Consequently, the transaction proposed herein will comply with the Commission's ownership rules because, following its acquisition of the stations, L&L will own six radio stations (2 AMs and 4 FMs) in the Peoria, IL Metro.

All of the stations listed above are geographically located in and “home” to the Biloxi-Gulfport-Pascagoula, MS Arbitron Metro. Accordingly, demonstrating compliance with the Commission’s radio multiple ownership restrictions requires only an analysis based on a count of radio stations in the Biloxi-Gulfport-Pascagoula, MS Metro.

As demonstrated in the attached BIA printout (Attachment B), the Biloxi-Gulfport-Pascagoula, MS Metro contains 24 full power radio stations. In markets with between 15 and 29 full power radio stations, Section 73.3555(a) of the Commission’s rules allows common control of up to six radio stations, not more than four of which are in the same service.

Consequently, the transaction proposed herein will comply with the Commission’s ownership rules because, following its acquisition of the stations, L&L will own six radio stations, (2 AMs and 4 FM) in the Biloxi-Gulfport-Pascagoula, MS Metro.

Five of the stations listed above are geographically located in and “home” to the Fargo-Moorhead, ND-MN Arbitron Metro. KBMW(AM) is located in Breckenridge, MN, outside of any Arbitron Metro. No party to this application has an attributable interest in any other radio station that is located in the same market as, or has contour overlap with, any of these stations. Because KBMW(AM) is not home to the Fargo-Moorhead, ND-MN Metro and is licensed to a community that is geographically located outside of the Fargo-Moorhead, ND-MN (and all other Arbitron Metros), both an analysis based on a count of stations in the Fargo-Moorhead, ND-MN Metro and an analysis under the FCC’s interim contour overlap methodology are required in order to demonstrate compliance with the FCC’s multiple ownership rules.

Arbitron Metro Analysis

As described above, five stations of the stations that L&L proposed to acquire are geographically located in and “home” to the Fargo-Moorhead, ND-MN Arbitron Metro. Accordingly, demonstrating compliance with the Commission’s radio multiple ownership restrictions requires only an analysis based on a count of radio stations in the Fargo-Moorhead, ND-MN Metro.

As demonstrated in the attached BIA printout (Attachment C), the Fargo-Moorhead, ND-MN Metro contains 28 full power radio stations. In markets with between 15 and 29 full power radio

stations, Section 73.3555(a) of the Commission's rules allows common control of up to six radio stations, not more than four of which are in the same service.

Consequently, the transaction proposed herein will comply with the Commission's ownership rules because following its acquisition of the stations, L&L will own five radio stations (1 AM and 4 FMs) in the Fargo-Moorhead, ND-MN Metro.

Contour Overlap Analysis

Attached (Attachment C) is a contour overlap study prepared by Hatfield & Dawson which depicts the single market created by the overlapping contours of the six stations listed above that are proposed to be assigned to L&L. As demonstrated in Attachment C, the market contains at least 29 stations. In markets with between 15 and 29 full power radio stations, Section 73.3555(a) of the Commission's rules allows common control of up to six radio stations, not more than four of which are in the same service. Consequently, the transaction proposed herein will comply with the Commission's ownership rules because, following its acquisition of the stations, L&L will own six radio stations (2 AMs and 4 FMs) in the market defined by the stations' contour overlap.

Only one of the stations listed above is geographically located in and "home" to the Savannah GA Arbitron Metro. While proximate to Savannah, the other five are located near Hilton Head, SC, which is outside of any Arbitron Metro. No party to this application has an attributable interest in any other radio station that is located in the same market as, or has contour overlap with, any of these stations. Because five of the above-listed stations are not home to the Savannah, GA Metro and are licensed to communities located outside of any Arbitron Metro, both an analysis based on a count of stations in the Savannah, GA Metro and an analysis under the FCC's interim contour overlap methodology are required in order to demonstrate compliance with the FCC's multiple ownership rules.

Arbitron Metro Analysis

As described above, only one station, WGCO(FM) is geographically located in and “home” to the Savannah, GA Arbitron Metro. As demonstrated in the attached BIA printout (Attachment D), the Savannah, GA Metro contains 26 full power radio stations; regardless, ownership of a single station in the market is permissible under Section 73.3555(a) of the Commission’s rules.

Contour Overlap Analysis

Attached (as Attachment D) are contour overlap studies prepared by Hatfield & Dawson which depict the two separate markets created by the overlapping contours of the following stations that are proposed to be owned by L&L:

As shown in Hatfield & Dawson’s Cluster A map, the following five stations have common overlap in a market with at least 21 stations:

- WHHW(AM)
- WGZO(FM)
- WFXH-FM
- WXYX(FM)
- WUBB(FM)

In markets with between 15 and 29 full power radio stations, Section 73.3555(a) of the Commission’s rules allows common control of up to six radio stations, not more than four of which are in the same service. In this market, the transaction proposed herein will comply with the Commission’s ownership rules because following its acquisition of the stations, L&L will own five radio stations (1 AM and 4 FMs).

As shown in the Hatfield & Dawson’s Cluster B map, the following three stations have common overlap in a market with at least 32 stations:

- WHHW(AM)
- WUBB(FM)
- WGCO(FM)

In markets with between 30 and 44 full power radio stations, Section 73.3555(a) of the Commission’s rules allows common control of up to 7 radio stations, not more than four of which are in the same service. In this market, the transaction proposed herein will comply with the Commission’s ownership rules because following its acquisition of the stations, L&L will own three radio stations (1AM and 2 FMs).

All of the stations listed above are geographically located in and “home” to the Bluefield, WV Arbitron Metro. Accordingly, demonstrating compliance with the Commission’s radio multiple ownership restrictions requires only an analysis based on a count of radio stations in the Bluefield, WV Metro.

As demonstrated in the attached BIA printout (Attachment E), the Bluefield, WV Metro contains 20 full power radio stations. In markets with between 15 and 29 full power radio stations, Section 73.3555(a) of the Commission’s rules allows common control of up to six radio stations, not more than four of which are in the same service.

In this market, the transaction proposed herein will comply with the Commission’s ownership rules because following its acquisition of the stations, L&L will own six radio stations, (2 AM and 4 FMs). (Note that while Assignor holds the licenses for two additional stations in the Bluefield market, WTZE(AM) and WKQY(FM), these stations will not be assigned to L&L and are not part of the instant application. Section 1.1 of the Purchase Agreement provides that L&L may identify a third-party buyer for these stations prior to closing, in which case an application proposing to assign the license from Assignor to the third party buyer will be filed with the Commission. Alternatively, Assignor may surrender the licenses prior to closing.)

The attached analysis of compliance with the radio multiple ownership rules was prepared in accordance with the Rules and Regulations of the Federal Communications Commission, in connection with an assignment application for various radio stations to L&L Broadcasting LLC.

Fargo Unrated Market Analysis

L&L proposes to acquire the following stations in the vicinity of Fargo, North Dakota:

KLTA(FM)	286C1	Breckenridge, MN
KPFX(FM)	300C1	Fargo, ND

While Fargo-Moorhead is an Arbitron-rated market, AM station KBNW 1450 kHz Breckenridge is not included in the BIA listing and the community of license is located outside the Fargo-Moorhead metro counties. Therefore, an analysis has been made consistent with the Commission's interim rules for unrated markets. The 70 dBu contours of FM stations were determined from the technical data contained in the most recent edition of the FCC FM Database. The listed antenna height above average terrain was used together with topographic data obtained from the digitized 30 second or 3 second database. The 5 mV/m daytime contours of AM stations were determined from the technical data contained in the most recent edition of the FCC AM Database. The listed antenna parameter information was used together with a digitized version of the FCC M-3 or Region II ground conductivity database.

The service contours were plotted using correct map projection mathematics. Those stations whose transmitter sites are within the respective principal community service contours of the stations proposed to be commonly owned have only the sites rather than their contours shown. All contours and enclosed transmitter site locations have been labeled. A list of all stations considered is included with this statement.

In counting stations providing service to the "market" defined by each of the discrete clusters formed in unrated markets, stations whose transmitter sites are located in excess of 92 km from the perimeter of the common overlap area have been excluded, as have other stations to be commonly-owned but which are not a part of the discrete cluster being studied.

The stations to be commonly-owned form a single cluster in that they all have common overlap in the same area. This exhibit evidences at least the minimum number of stations necessary to demonstrate compliance with the rules concerning radio multiple ownership in unrated markets. In order to qualify for common ownership of this 2AM/4FM cluster, there must be at least 15 stations in the relevant "market". This study demonstrates that there are at least 29 stations in the relevant market.



Hilton Head Unrated Market

L&L proposes to acquire the following stations in the vicinity of Hilton Head, South Carolina:

Of these stations, only WGCO is licensed to a community within an Arbitron rated market (Savannah). The remaining stations serve the unrated Hilton Head market.¹ Therefore, analysis has been made consistent with the Commission's interim rules for unrated markets. The 70 dBu contours of FM stations were determined from the technical data contained in the most recent edition of the FCC FM Database. The listed antenna height above average terrain was used together with topographic data obtained from the digitized 30 second or 3 second database. The 5 mV/m daytime contours of AM stations were determined from the technical data contained in the most recent edition of the FCC AM Database. The listed antenna parameter information was used together with a digitized version of the FCC M-3 or Region II ground conductivity database.

¹ Hilton Head was until recently an Arbitron-rated market, but was dropped in mid-2011.

The service contours were plotted using correct map projection mathematics. Those stations whose transmitter sites are within the respective principal community service contours of the stations proposed to be commonly owned have only the sites rather than their contours shown. All contours and enclosed transmitter site locations have been labeled. A list of all stations considered is included with this statement.

In counting stations providing service to the "market" defined by each of the discrete clusters formed in unrated markets, stations whose transmitter sites are located in excess of 92 km from the perimeter of the common overlap area have been excluded, as have other stations to be commonly-owned but which are not a part of the discrete cluster being studied. The attached overview map demonstrates that the stations to be commonly-owned form two discrete clusters.

Cluster A: WHHW(AM), WGZO(FM), WFXH-FM, WXYF(FM), WUBB(FM)

This exhibit evidences at least the minimum number of stations necessary to demonstrate compliance with the rules concerning radio multiple ownership in unrated markets. In order to qualify for common ownership of this 1AM/4FM cluster, there must be at least 15 stations in the relevant "market". This study demonstrates that there are at least 21 stations in the relevant market.


Cluster B: WHHW(AM), WUBB(FM), WGCO(FM)

This exhibit evidences at least the minimum number of stations necessary to demonstrate compliance with the rules concerning radio multiple ownership in unrated markets. In order to qualify for common ownership of this 1AM/2FM cluster, there must be at least 6 stations in the relevant "market". This study demonstrates that there are at least 32 stations in the relevant market.
