In evaluating the proposed minor modification application for K17DD/K38IM FID 40743 an outgoing interference study was executed at the proposed tower location using the proposed parameters as outlined in the application. The stations listed in the table below showed possible interference. When these stations were evaluated for outgoing interference using the OET-69 Longley Rice methodology, the interference, when rounded to the nearest whole percent, was found to be zero percent interference except in the case of K38EC (64.0% 16 people out of 25 receive interference). Emmis Broadcasting, owner of K38EC, has agreed to change their offset from None to Zero at our expense and has filed or is in the process of filing an application with the commission to reflect this change per the attached letter. This change will bring the population interfered with to 0.00%.
