Re: Notification of Temporary Discontinuance of Operations and Request for
Special Temporary Authority to Remain Silent; KJCU(FM), Laytonville,
California (FIN: 87930)

Dear Ms. Dortch:

CSN International ("CSN"), licensee of noncommercial educational FM broadcast station KJCU, Laytonville, California, hereby (1) notifies the Commission, pursuant to Section 73.561 of the Commission's Rules, that it has temporarily suspended broadcast operations at KJCU due to technical issues associated with its main studio, and (2) requests Special Temporary Authority ("STA") pursuant to Section 73.1635 of the Commission's Rules, to remain silent for a period of 90 days and/or to operate on a temporary basis as a satellite of station WHLP(FM), Hanna, Indiana, a broadcast facility also licensed to CSN and capable of feeding KJCU.

CSN has determined that major technical corrections and enhancements are needed in the studio facilities for KJCU. Although CSN is reluctant to discontinue operations, management has concluded, based on a thorough engineering audit, that continuing operations with the present studio facilities at KJCU would be infeasible without significant technical changes. CSN therefore suspended operations at KJCU on April 4, 2006, pending CSN's undertaking a significant amount of work to bring the studio facilities up to standards. CSN currently estimates that broadcast operations from modified studio facilities can commence within the next ninety (90) days. CSN therefore requests Special Temporary Authority to remain silent for a period of 90 days. CSN will take all necessary steps to resume normal operations in an expeditious and timely manner.



However, rather than allowing the station to go silent, CSN also hereby requests Special Temporary Authority to operate KJCU, on a temporary basis, as a "satellite" of station WHLP, also licensed to CSN, at Hanna, Indiana. Temporary authority to operate with a main studio outside the community of license would ensure that CSN programming remains available to the KJCU service area during this period. Consistent with the criteria used in granting permanent waivers of the main studio location rule, Section 73.1125(a), CSN hereby represents that it will continue to maintain the station's public file in Laytonville, and will maintain a toll-free telephone line between Laytonville and Hanna by which residents can contact CSN management. CSN is not, however, requesting a permanent waiver of the main studio location rule and will only retransmit the signal of WHLP until such time as service from the main studio for KJCU can be restored.

Attached is an Anti-Drug Abuse Act Certification executed by CSN. Because CSN is a noncommercial educational licensee, no filing fee is required.
