

PARTIES TO THE APPLICATION

CBS Radio Holdings, Inc. is a wholly owned subsidiary of CBS Radio Stations Inc., which in turn is a wholly owned subsidiary of CBS Radio Media Corporation ("CBS Media"). CBS Media is a wholly owned subsidiary of CBS Radio Inc. ("CBS Radio"). CBS Radio is a wholly owned subsidiary of CBS Broadcasting Inc., which in turn is a wholly owned subsidiary of Westinghouse CBS Holding Company, Inc. ("Westinghouse"). Westinghouse is a wholly owned subsidiary of CBS Corporation. CBS Corporation is a publicly-traded company that is controlled by a single majority voting shareholder, NAIRI, Inc. ("NAIRI"), through its approximately 81% voting interest.¹

NAIRI is a wholly-owned subsidiary of National Amusements, Inc. ("NAI"). NAI is controlled by Sumner M. Redstone through the Sumner M. Redstone National Amusements Trust u/d/t dated 6/28/02 ("Sumner M. Redstone Trust"), which owns approximately 80% of the voting interest of NAI.¹ Sumner M. Redstone, David Andelman, Phyllis Redstone, George Abrams, Norman I. Jacobs, Leonard L. Lewin and Philippe Dauman are the trustees of the Sumner M. Redstone Trust. Voting shares of the Sumner M. Redstone Trust are voted solely by Sumner M. Redstone until such time as his incapacity or death. The Shari Ellin Redstone Trust u/d/t October 18, 1999, as amended December 9, 2004 ("Shari E. Redstone Trust") owns approximately 20% of the voting interest.¹ Shari E. Redstone is the trustee of the Shari E. Redstone Trust.

Because CBS Corporation is controlled by a single majority voting shareholder, NAIRI, no minority ownership interests in CBS Corporation are attributable. On December 14, 2001, the Commission suspended the elimination of the single majority shareholder exemption for purposes of the broadcast and cable/MDS attribution rules pending the resolution of the Commission's Further Notice of Proposed Rulemaking in CS Docket Nos. 98-82, 96-85, and MM Docket Nos. 92-264, 94-150, 92-51 and 87-154. *Review of the Commission's Regulations Governing Attribution of Broadcast and Cable/MDS Interests*, FCC 01-353 (released December 14, 2001).

In addition, no person or entity holds more than 33% of the total assets (debt plus equity) of CBS Corporation. Therefore, no person or entity has an attributable interest in CBS Corporation under the Equity/Debt Plus ("EDP") Rule. *See* 47 C.F.R. § 73.3555 Note 2(i).

¹ The voting interest held by NAIRI in CBS Corporation and the voting interests held by Sumner M. Redstone Trust and the Shari E. Redstone Trust in NAI are attributable under the Commission's multiple ownership rules. For this reason, the percentage of total assets held by NAIRI and the two trusts in these entities are not relevant for the purpose of determining attribution, and therefore are not disclosed here.
