Dear Ms. Dortch:

I am personal attorney to Madeline Gussman, Surviving Spouse of Marvin Gussman.

This letter is with respect to an application for consent to transfer of control of certain full-power digital television stations and TV translator facilities licensed to Wyomedia Corporation ("Wyomedia") from Marvin Gussman (now deceased) to his surviving wife, Madeline Gussman.

Marvin Gussman was the sole shareholder of Wyomedia at the time of his death. Under California "community property" law, Mr. Gussman's wife held an undivided one-half interest in the Wyomedia stock and Mr. Gussman held the other undivided one-half interest.

Under *California Probate Code* Section 13650(a), a Surviving Spouse who is the sole heir of her deceased spouse may file a Spousal Property Petition requesting an Order from the Court that administration of the Estate is not necessary since the entirety of the Estate is passing to the Surviving Spouse. Additionally, the Petition may request an Order confirming to the Surviving Spouse her interest in the property involved. Provided here as Attachment "A" is a copy of the Spousal Property Petition filed October 29, 2009 with the Superior Court of California, County of Los Angeles, requesting that the property involved be determined by the Court as having passed to Madeline Gussman from her deceased spouse, and requesting that

the property belonging to the Surviving Spouse (one-half of the community property) be confirmed to the Surviving Spouse. Those portions of Attachment "A" which reflect assets of the Decedent and Surviving Spouse other than shares of Wyomedia Corporation have been whited out or in the case of Pages 1, 2 and 4 of the Attachment to the Petition, are not included.

A hearing was held before the Los Angeles Superior Court February 2, 2010. The Court approved the Petition of Ms. Gussman and subsequently signed a Spousal Property Order, which was filed February 8, 2010. A copy of the Court Order accompanies this letter as Attachment "B". Those portions of the Order reflecting assets other than shares of Wyomedia Corporation have been whited out, and those pages which list assets unrelated to Wyomedia have been deleted.

I declare this to be my Will and revoke all former Wills and Codicils. I am a citizen of the United States of America.

**CLAUSE FIRST: Marital Status And Family.**

I am married to Madeline Gussman, who in this Will is referred to as "Madeline." We have the following children, all of whom are adults: Howard Gussman ("Howard"), Cheryl Gussman-Kaupp ("Cheryl"), Michelle Crandell, David Gussman ("David"), and Lisa Zairi. I have no other living child or deceased child leaving a descendant. All references in this instrument to my children, grandchildren, and more remote descendants shall include only said children and the descendants of said children.

**CLAUSE SECOND: Nomination Of Executor.**

I hereby nominate the following persons to act as Executor. If the first nominee or any successor nominee is unable, is unwilling, or ceases to act, the next of them shall act in the order named. No bond shall be required of any Executor named below or nominated as provided herein (except to the extent required by the terms of a nomination), and each Executor shall have the unqualified right to resign. The right to nominate shall include the right to nominate a Coexecutor to serve with the person making the nomination and the right to nominate a series of successor Executors and Coexecutors.

- A. Madeline, as sole Executor;
- B. Howard and Cheryl, acting together as Coexecutors;
- C. If either Howard or Cheryl is unable, is unwilling, or ceases to act, David shall act with the other of them as a Coexecutor;
- D. If only one of Howard, Cheryl, or David is able and willing to act, that one of them shall act alone as sole Executor; or
- E. The nominee or nominees of the last acting Executor.

CLAUSE THIRD: Property Governed By Will.

I intend that my Will dispose of all property wherever situated that I have the power to dispose of by will at my death (specifically including those described in California Probate Code Section 5000), but I do not intend to exercise any power of appointment by this Will at my death. I do not intend that my Will dispose of Madeline's one-half interest in any community property we own at my death, and I hereby confirm the same to Madeline.

CLAUSE FOURTH: Gift Of All Property.

A. Gift Of All Property To Madeline.

I give all of my property to Madeline, if Madeline survives me.

B. Contingent Gift Of All Property.

If Madeline fails to survive me, I give all of my property to my descendants who survive me, according to the principle of representation, subject the provisions of paragraph E of CLAUSE SEVENTH below.

CLAUSE FIFTH: Executor's Powers.

A. I authorize my Executor to sell, lease, mortgage, or encumber the whole or any part of my estate, with or without notice. My Executor shall have absolute discretion as to how much cash, if any, to invest at interest.

B. I authorize my Executor to invest and reinvest funds of my estate, including surplus cash and the proceeds from the sale of any assets of my estate, in every kind of property, specifically including, but not by way of limitation, corporate or governmental obligations of every kind, securities of any regulated investment trust, and preferred or common stocks.

C. I authorize my Executor, in my Executor's absolute discretion, to make any one or more of the elections allowed by the Internal Revenue Code or the tax law of any state, without regard to conflicting interests of those interested in my estate and without making any adjustment among them.

D. Upon any division or partial or final distribution of my estate, I authorize my Executor to apportion and allocate the assets of my estate in cash or in kind, or partly in cash and partly in kind, or in undivided interests, in such manner as my Executor shall determine and to sell any property deemed necessary by my Executor in connection therewith.



CLAUSE SIXTH: Payment Of Taxes.

I direct that all estate, inheritance, or other death taxes occasioned or payable by reason of my death be charged to and collected from the interests of the persons sharing in my taxable estate as and to the extent provided by law, except that any interest in a college savings plan established under Internal Revenue Code Section 529 that is includible in my taxable estate shall be free of any such death tax.

CLAUSE SEVENTH: Interpretation Of This Will.

A. As used in this Will and to the extent appropriate the masculine, feminine, and neuter gender shall include the other two genders, the singular shall include the plural, and the plural shall include the singular.

B. As used in this Will, the terms "descendant" and "descendants" shall be interpreted as provided by California law, except that the parent-child relationship shall not include persons adopted after attaining majority.

C. If any beneficiary of this Will fails to survive me for 90 days, then for all purposes of this Will such beneficiary shall be deemed to have predeceased me.

D. Although Madeline and I are executing Wills on or about the same date that contain similar provisions, we are not doing so pursuant to any contract or agreement between us. The survivor of us shall retain the absolute power to change his or her estate plan.

E. Any property distributable under this Will to any beneficiary who has not attained age 25 shall be held for such beneficiary by a custodian selected by my Executor, without bond, under the California Uniform Transfers to Minors Act (or similar statute in effect in the jurisdiction in which such beneficiary resides), until such beneficiary attains said age (or until the beneficiary attains the maximum age permitted under the statute in effect in the jurisdiction under which such custodianship is governed).

CLAUSE EIGHTH: Provision Against Contest.

I have intentionally and with full knowledge omitted to provide for my heirs, except for such provisions as are made specifically in this Will. If any person who is or claims under or through a devisee of this Will, in any manner whatsoever, directly or indirectly contests or attacks this Will, takes any action that would frustrate the dispositive plan contemplated in this Will, conspires or cooperates with anyone attempting to contest, attack, or frustrate this Will, or takes any of the actions set forth in items A through C below (such person hereinafter referred to as an "Objector"), then I specifically disinherit each such Objector. In that event, each Objector

shall be treated as having predeceased me for all purposes of this Will. For purposes of this CLAUSE, a contest shall include, but not be limited to, the following actions: (A) filing a creditor's claim or prosecution of an action based thereon, (B) commencing any legal action or proceeding to determine the character, title, or ownership of property, and (C) challenging the validity of any instrument, contract, agreement, beneficiary designation, or other document executed by me and pertaining to the disposition of my assets (including, but not limited to, any buy-sell agreement or the beneficiary designation of any annuity, insurance policy, or retirement plan account). Notwithstanding the foregoing, this CLAUSE shall not apply to any person solely by reason of such person taking an action described in items A through C above, or responding to any such action taken by another, if such action or response is unopposed by my Executor (even if my Executor is also a beneficiary of any of my assets under this Will or otherwise), and my Executor shall not be liable in any manner to any beneficiary or any other person or entity for opposing or not opposing any such action or response. This CLAUSE shall not apply to any charitable beneficiary. My Executor is authorized to defend, at the expense of my estate, any contest or other attack of any nature on this Will. Except as provided to the contrary in any Codicil to this Will, this CLAUSE shall not apply to such Codicil.
