- The members of **Lilly Northeast Broadcast, LLC** are Kevin T. Lilly (Manager/30% Member/President), Nicholas White (30% Member), Brian M. Lilly (30% Member), Robert D. McCurdy (5% Member), and Walt Ward (5% Member).
- The members of **SJL Northeast Broadcast, LLC** are George D. Lilly (43% Member/Chairman/Board Representative), Pamela Davis Heilman (Secretary), Denise Hopkins (1% Member), Carole Henery (1% Member), Wade O'Hagen (2% Member), Robert D. McCurdy (5% Member, Vice President/Board Representative/Treasurer), Walt Ward (5% Member/Board Representative), and Sandra G. Benton (43% Member/President/Board Representative).
