

1. Notwithstanding any other provisions of these articles, the purposes for which the corporation is organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
2. Notwithstanding any other provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
3. Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future federal tax code, or shall be distributed to the federal government, or to a state or local government for a public purpose. Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated for such purposes.

**UNANIMOUS WRITTEN CONSENT OF THE BOARD OF DIRECTORS OF  
NETWORK OF GLORY, LLC TO AMEND THE BYLAWS AND ARTICLES OF  
ORGANIZATION OF NETWORK OF GLORY, LLC**

**WHEREAS**, Network of Glory, LLC (“NOGLLC”) will submit 10 applications to the Federal Communications Commission (“FCC”) during the FCC’s October 12 – October 19, 2007 filing window for noncommercial educational FM stations (the “Applications”); and

**WHEREAS**, there are likely to be competing applicants for the frequencies sought by NOGLLC, and in such cases the FCC selects the applicant who achieves the highest score under certain criteria, one of which is “diversity of ownership,” which favors applicants who certify that they and their officers and directors do not, and may not under the applicant’s organizational rules, have an “attributable” (ownership or official) interest in other radio stations whose principal community (or city grade) contours overlap the principal community contour of the station applied for; and

**WHEREAS**, it is appropriate to enable such certifications through amendments to NOGLLC’s Bylaws and Articles of Organization, because NOGLLC neither operates nor intends to apply for other stations the principal community contours of which would overlap the applicable contours specified in the Applications and because none of NOGLLC’s members, officers or directors are known to have attributable interests in any such stations.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Directors that Article X of the Bylaws of NOGLLC is hereby amended to read, in its entirety, as follows:

“10.1: As required by the FCC’s rules, Network of Glory, LLC (“NOGLLC”) shall maintain local diversity of ownership as follows: (i) NOGLLC shall not seek consent from the FCC to obtain an AM, FM, or FM translator station the principal community contour of which would overlap any of the principal community contours of the facilities proposed in any of the 10 applications submitted by NOGLLC to the Federal Communications Commission (“FCC”) during the FCC’s October 12 – October 19, 2007 filing window for noncommercial educational FM stations (the “Applications”) that are granted by the FCC based on its evaluation of local diversity of ownership points; (ii) NOGLLC shall not elect, appoint, or permit to serve as a member, officer or director of NOGLLC any person who has an attributable interest in any AM, FM or FM translator station the principal community contour of which would overlap the principal

community contour of the facilities proposed in any of the Applications granted by the FCC based on its evaluation of local diversity of ownership points; and (iii) NOGLLC shall not take any other action that would eliminate NOGLLC's entitlement to any FCC credit for diversity of ownership received in connection with any of the Applications. The provisions of this paragraph shall expire and have no force or effect with respect to an Application if and at such time as the FCC dismisses or denies that Application and that action becomes final. The definitions of the terms "principal community contour," "attributable," and "final" shall be those contained in the rules, regulations, and policies of the FCC."

**FURTHER, BE IT RESOLVED** by the Board of Directors that the Articles of Organization of NOGLLC are hereby amended to read as follows:

"Notwithstanding any other provisions of these Articles, as required by the FCC's rules, Network of Glory, LLC ("NOGLLC") shall maintain local diversity of ownership as follows: (i) NOGLLC shall not seek consent from the FCC to obtain an AM, FM, or FM translator station the principal community contour of which would overlap any of the principal community contours of the facilities proposed in any of the 10 applications submitted by NOGLLC to the Federal Communications Commission ("FCC") during the FCC's October 12 – October 19, 2007 filing window for noncommercial educational FM stations (the "Applications") that are granted by the FCC based on its evaluation of local diversity of ownership points; (ii) NOGLLC shall not elect, appoint, or permit to serve as a member, officer or director of NOGLLC any person who has an attributable interest in any AM, FM or FM translator station the principal community contour of which would overlap the principal community contour of the facilities proposed in any of the Applications granted by the FCC based on its evaluation of local diversity of ownership points; and (iii) NOGLLC shall not take any other action that would eliminate NOGLLC's entitlement to any FCC credit for diversity of ownership received in connection with any of the Applications. The provisions of this paragraph shall expire and have no force or effect with respect to an Application if and at

such time as the FCC dismisses or denies that Application and that action becomes final. The definitions of the terms "principal community contour," "attributable," and "final" shall be those contained in the rules, regulations, and policies of the FCC."
