Purpose of Amendment

This amendment is being filed to clear the Kanza Society's Inc.'s application **BNPED - 20071018BDH** (Guymon, OK) from four applications filed as part of the October 19, 2007 NCE Filing Window with which it is likely mutually exclusive:

- **BNPED-20071018AKG** (Liberal, KS), TOP O TEXAS EDUCATIONAL BROADCASTING FOUNDATION
- **BNPED-20071018ALG** (Perryton, TX), GREAT PLAINS CHRISTIAN RADIO, INC.
- **BNPED-20071022BFX** (Borger, TX), EDUCATIONAL MUSIC FOUNDATION
- **BNPED-20071022BQU** (Claude, TX), GRACE COMMUNITY CHURCH OF AMARILLO

It proposes a change from CH 217 to CH 220, a lower ERP, use of a directional antenna, and a lower center of radiation AMLS at the same transmitter site specified in the original application. As detailed in Exhibit 16 of the amendment, the proposed new facility as amended does not conflict with any other existing station, existing authorization, or application from the October 19, 2007 filing window that has been tendered for filing or accepted for filing.
