### Equal Employment Opportunity Records:

The FCC audited the station EEO program in 2016 (auditing records associated with the employment unit's 2014 and 2015 EEO Public File Reports) and 2018 (auditing records associated with the employment unit's 2016 and 2017 EEO Public File Reports).

In each case, audit material was uploaded to the Online Public Inspection File ("OPIF") EEO Audits/Investigations folder on a timely basis in February 2018 in conjunction with the March 1, 2018, initial online PIF compliance deadline.
