

**SP Little Rock LLC**

Equity Media Holdings Corporation, Debtor In Possession (“Seller”) is the licensee of KLRA-LP, Little Rock, AR (Facility ID No. 57548) and KEJC-LP, Sheridan, AR (Facility ID No. 24263) (the “Stations”). On December 16, 2008, Seller filed a voluntary petition for relief under chapter 11 of title 11 of the United States Code, 11 U.S.C. Sections 101-1532 (as amended) with the United States Bankruptcy Court for the Eastern District of Arkansas (the “Bankruptcy Court”). Its chapter 11 case is being jointly administered with those of its subsidiaries under Case No. 4:08-BK-17646.

On June 2, 2009, Seller entered into an Asset Purchase Agreement (the “Agreement”) with Silver Point Finance, LLC, as the agent on behalf of the lenders under a Debtor-in-Possession Financing Agreement. Silver Point Finance, LLC has since assigned to SP Little Rock LLC (“Buyer”) its rights and obligations under the Agreement. Pursuant to the Agreement, Seller agreed to sell, transfer and assign, and Buyer agreed to purchase, acquire and assume, certain assets of the Stations, including the FCC licenses for the Stations, subject to FCC requirements and an order of the Bankruptcy Court authorizing and approving such sale pursuant to Sections 363 and 365 of the Bankruptcy Code. The parties anticipate Bankruptcy Court approval shortly. Consequently, by this application, Buyer and Seller seek FCC consent to the assignment of the broadcast licenses for the Stations listed from Seller to Buyer.
