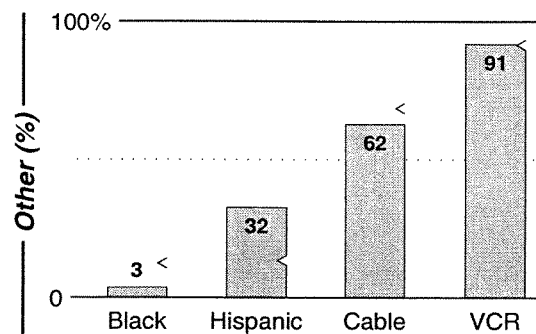
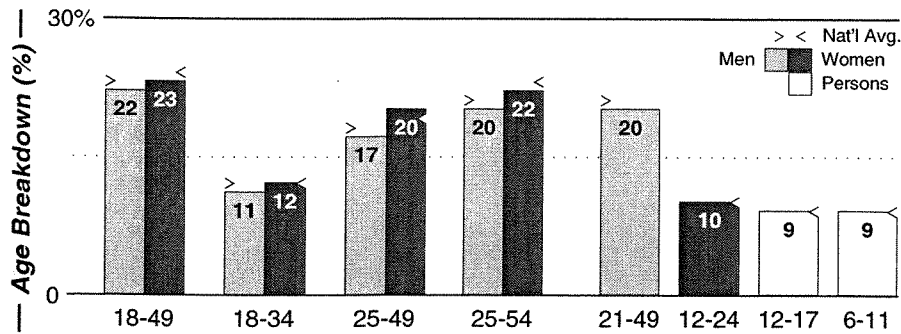
**Amended Multiple Ownership Exhibit**

In order to demonstrate compliance with the Commission's recently adopted broadcast multiple ownership rules, Univision Television Group, Inc. ("UTGI") hereby amends the Multiple Ownership section of its application seeking Commission consent to the assignment of license of KXGR(TV), Green Valley, Arizona, located in the Tucson, Arizona DMA.

As shown in Exhibit 14 of the original application, Univision Communications Inc., the parent of UTGI, currently holds an attributable interest in KFTU(TV), Douglas, Arizona, which is also licensed to the Tucson, Arizona DMA. Under the Commission's new local television multiple ownership rules, a single entity may own two television stations in a market that has five or more television stations, as long as both stations are not among the top four ranked stations in that market. *See* 47 C.F.R. § 73.3555(b)(2)(i). According to the attached information from *Television Yearbook 2003*, BIA Financial Network (2003), there are more than nine commercial and noncommercial television stations in the Tucson, Arizona DMA, and neither KXGR(TV) nor KFTU(TV) are rated among the top four stations in the market. Accordingly, Univision's ownership of an attributable interest in KXGR(TV) and KFTU(TV) in the Tucson, Arizona DMA fully complies with the Commission's new multiple ownership rules.
