

DESCRIPTION OF THE TRANSACTION

The instant application is one of several simultaneously filed applications (collectively, the “FCC Long Form Applications”) seeking consent of the Federal Communications Commission (“FCC” or “Commission”), pursuant to the Chapter 11 Joint Plan of Reorganization, as modified (“Chapter 11 Plan” or “Plan”), filed by Citadel Broadcasting Corporation (“Citadel”) together with other Debtors (as hereafter defined) with the United States Bankruptcy Court of the Southern District of New York (“Bankruptcy Court”), to the transfer of control of the subsidiaries of Citadel that hold broadcast licenses listed on Attachment A hereto (“Citadel Licensee Subsidiaries” and together with Citadel, the “Debtors”) from the shareholders of Citadel Broadcasting Corporation, Debtor-In-Possession, to the shareholders of Citadel Broadcasting Company (the surviving company after the reorganization described in the Plan and below).

I. Background

On December 20, 2009, the Debtors filed voluntary petitions (“Petitions”) in the Bankruptcy Court seeking relief under the provisions of chapter 11 of the Bankruptcy Code to effectuate a pre-negotiated restructuring of the debt obligations of the Debtors.¹ Accordingly, the Debtors are now operating as debtors-in-possession under the Bankruptcy Court’s oversight. Following this filing, on December 22, 2009, the Citadel Licensee Subsidiaries filed applications seeking the FCC’s consent to the *pro forma* assignment of the Citadel Licensee Subsidiaries’ FCC licenses from the Citadel Licensee Subsidiaries to the Citadel Licensee Subsidiaries as “debtors-in-possession” under chapter 11. The FCC granted these applications on December 30, 2009. See FCC File No. BAL-20091222ABU-AJX, BAL-20091222AJZ-AKB, BALH-20091222AKI-AKJ, BALH-20091222AKK-AKO, BAL-20091222AKP-AKR, BALH-20091222AKS, BAL-20091222AKT, BAL-20091222AKY-ALA, BAL-20091222ALC-ALD, BALH-20091222ALH, BAL-20091222ALI, BAL-20091222ALM and BALH-20091222ALN.

II. The Reorganization Plan.

On February 3, 2010, the Debtors filed the Chapter 11 Plan with the Bankruptcy Court.² The Plan, as modified, contemplates that, on and after the effective date of the Plan, the Debtors will cease to be debtors-in-possession and will be reorganized in accordance with the applicable bankruptcy law. Pursuant to the Chapter 11 Plan, on the Debtors' emergence from bankruptcy, all of the currently outstanding equity interests of the Debtors will be cancelled and extinguished. On the effective date, Citadel will merge with and into Citadel Broadcasting Company ("CB Company"), a Nevada corporation which is the licensee of certain of the broadcast stations listed on Attachment A, with CB Company as the surviving entity. The assets of Citadel shall be transferred to CB Company and new common stock and special warrants in CB Company shall be issued. The ownership of CB Company following the restructuring is described below. Upon the restructuring, Alphabet Acquisition Corp., the indirect parent of certain of the Citadel Licensee Subsidiaries, shall be wholly-owned by CB Company. In addition, a new limited liability company, which shall be wholly-owned by CB Company, shall be established ("CB Company Licensee Subsidiary"). The Debtors shall file *pro forma* assignment applications requesting consent to assign the FCC licenses held by Citadel Licensee Subsidiaries, as debtors-in-possession, to the Citadel Licensee Subsidiaries, as reorganized following emergence from bankruptcy. The *pro forma* assignment application for CB Company shall request consent to assign the licenses of CB Company, as debtor-in-possession, to CB Company Licensee Subsidiary. Each of the Citadel Licensee Subsidiaries and CB Company Licensee Subsidiary shall continue to exist after the effective date as a separate entity.

The Plan also provides that in the event all conditions precedent to confirmation of the Plan have been satisfied but the Commission has not approved the FCC Long Form Applications, the Debtors shall, upon receipt of consent from certain holders of senior secured claims, establish a liquidating trust for the benefit of holders of allowed claims (as set forth in the Plan) that may be entitled to distributions from the trust under the Plan. The trust would be established and operated pursuant to the continuing jurisdiction and oversight of the Bankruptcy Court and the trustees of the liquidating trust would include the members of the existing board of directors of Citadel. In the event the Debtors determine that the establishment of the liquidating trust may be necessary, they shall file with the Commission applications on FCC Form 316 ("Short Form FCC Applications") requesting FCC approval to the *pro forma* transfer of control

of the Citadel Licensee Subsidiaries and CB Company Licensee Subsidiary to the liquidating trust.

III. Ownership and Control of CB Company (following reorganization)

Pursuant to the Plan, upon the consummation of the reorganization, the entities that hold secured claims pursuant to debt issued under Citadel's senior credit agreement with J.P. Morgan Chase, N.A. as administrative agent and other financial institutions and lenders and related credit facilities ("Senior Claim Holders") collectively will be eligible to receive 90 percent of the new common stock of CB Company (subject to dilution on account of a management and/or director's equity incentive program) and holders of general unsecured claims ("Unsecured Claim Holders"), including the deficiency claims of the Senior Claim Holders, will collectively be eligible to receive up to 10 percent of the new common stock of CB Company and a pro rata share of \$36 million in cash.

In the event the Debtors determine to implement the liquidating trust described above to be in effect prior to FCC approval of the FCC Long Form applications, the new common stock of CB Company will be transferred to the liquidating trust and the Senior Claim Holders and Unsecured Claim Holders that make the certifications described herein will receive beneficial interests in the liquidating trust instead of new common stock.

Citadel estimates that there are approximately 489 Senior Claim Holders entitled to receive an allocation of new common stock of CB Company. Citadel has adopted an equity allocation mechanism intended to ensure CB Company's compliance with the alien ownership restrictions contained in Section 310(b) of the Communications Act of 1934, as amended, and the FCC's media ownership and attribution rules. Initially, each Senior Claim Holder and each Unsecured Claim Holder that elects to receive new common stock will receive special warrants. Warrant holders shall have no voting rights. Warrant holders shall be entitled to receive distributions, if applicable, unless a FCC ruling prohibits distributions to warrant holders or Citadel is advised by counsel that such a distribution is reasonably likely to cause Citadel to violate applicable FCC rules and regulations.

Prospective shareholders will be required to provide certifications to Citadel that at least 80% of the indirect and direct voting and ownership interests in such holders, as calculated in accordance with FCC rules, are held by U.S. citizens or U.S. entities. Senior Claim Holders and Unsecured Claim Holders that cannot provide this certification will retain the warrants and will only be eligible to receive new common stock in the event that Citadel has determined that

following the initial distribution of new common stock to senior lenders and holders of general unsecured claims, the aggregate percentage of new common stock owned or voted by non U.S. citizens or entities is less than 80%, in which case, all holders of special warrants that have provided an ownership certification to Citadel shall be deemed to exercise their special warrants on a pro rata basis among all such eligible holders, to receive new common stock up to the number of shares that causes the aggregate percentage of new common stock owned or voted by aliens to equal 20%. CB Company shall issue two classes of new common stock. Holders of Class B stock shall not have the right to vote on matters effecting the day to day operations and ordinary course business of CB Company and its subsidiaries. Holders of Class B stock shall have the right to vote on decisions that are outside of the ordinary course of business of the type previously approved by the Commission as minority investor protections.³ Holders of Class A stock shall have full voting rights.

To ensure compliance with the FCC's media ownership and attribution rules, upon consummation of the reorganization, no holder of new common stock shall be permitted to acquire more than 4.99 percent of Class A common stock.⁴ In determining whether any holder would hold more than 4.99% of the outstanding Class A common stock, such holder will be attributed with any stock held by another holder under common management with such holder or that otherwise would be aggregated under the FCC's ownership attribution rules. Thus, upon consummation of the reorganization, no individual or entity will have an attributable interest in CB Company through stock ownership.

CB Company will have a Board of Directors comprised of seven individuals. At this time, six of the seven board members have been selected and are listed in Exhibit 15. At such

time as the additional board member is selected, the parties shall amend the FCC Long Form Applications to provide information for the additional board member. Information with respect to the persons who will serve as officers of CB Company is provided at Exhibit 15. Because CB Company will be a public company, certain decisions that are outside of the ordinary course of business will require approval of the shareholders.

IV. Agreements

Copies of the Chapter 11 Plan (the *First Modified Joint Plan of Reorganization of Citadel Broadcasting Corporation and Its Debtor Affiliates Pursuant to Chapter 11 of the Bankruptcy Code*, filed with the Bankruptcy Court on March 15, 2010) and the Disclosure Statement (the *First Modified Disclosure Statement for the Joint Plan of Reorganization of Citadel Broadcasting Corporation and Its Debtor Affiliates Pursuant to Chapter 11 of the Bankruptcy Code*, filed with the Bankruptcy Court on March 15, 2010) are included as attachments to Exhibit 6. The applicants have submitted the Chapter 11 Plan and Disclosure Statement to the Bankruptcy Court. The Bankruptcy Court approved the Disclosure Statement on March 15, 2010, but has not yet issued an order confirming the Chapter 11 Plan ("Confirmation Order"). A confirmation hearing on the Plan is scheduled to be heard by the Bankruptcy Court on May 12, 2010. Accordingly, the FCC Long Form Applications will be amended to include the Confirmation Order assuming confirmation of the Chapter 11 Plan by the Bankruptcy Court. The parties have not filed the following exhibits to the Disclosure Statement: Exhibit B (Declaration of Randy L. Taylor pursuant to Rule 1007-2 of the Local Bankruptcy Rules for the Southern District of New York in Support of the First-Day Pleadings); Exhibit E (Financial Projections); Exhibit F (Valuation Analysis); and Exhibit G (Liquidation Analysis). The omitted material is voluminous, available to the public through the Bankruptcy Court, and not germane to the Commission's evaluation of this application and therefore, consistent with FCC precedent, need not be produced. Information contained in the omitted materials will be provided to the Commission upon request, subject to the parties' rights, where appropriate, to submit such information subject to regulations restricting public access to confidential and proprietary information.
