**NATURE AND EDUCATIONAL PURPOSES OF APPLICANT**

Red-C Apostolate: Religious Education for the Domestic Church (the proposed "Assignee") is a nonprofit, non-stock educational organization and is the proposed assignee of FM station KEDC, Hearne, Texas (the "Station"). The Assignee intends to operate the Station as a noncommercial educational facility pursuant to Section 73.503 of the Commission's Rules.<sup>1</sup>

The Assignee's governing documents specify its nonprofit nature and explain that its purpose is to provide educational programming to the communities it serves.

The FCC staff has concluded that religiously oriented applicants for noncommercial educational stations satisfy the requirements of Section 73.503 of the FCC's Rules by fulfilling two criteria.<sup>2</sup> First, the applicant must propose an overall educational program. Second, the proposed programming must advance the applicant's educational objectives. The full Commission has cited this two-prong test with approval.<sup>3</sup> As explained herein, the Assignee satisfies both elements of this test.

The Assignee will provide a noncommercial broadcast service for the purpose of advancing its educational objectives. The educational objectives of the Assignee include the following:

(1) To provide educational and religious instruction developed from the Holy Bible, Tradition and by the Magisterium of the Roman Catholic Church;

(2) To provide the opportunity for, and to promote, discussion informed by a Catholic perspective in areas pertaining to current contemporary social and religious issues; and

(3) To foster the development and implementation of successful methods, consistent with Catholic doctrine, for responding to community problems and the intrinsic needs of humanity.

In order to advance these and other educational purposes, the Assignee will not air commercials or advertisements. Rather, the Assignee will seek to provide radio service including religious perspectives on news and current affairs; instruction by individuals

trained in catechesis and evangelistic outreach, instructive talks by eminent teachers within the Catholic Church; and live airings of devotional prayers.

The Assignee will listen to local Roman Catholic clergy, parishes and other community organizations to assist and complement existing efforts to administer to the spiritual, intellectual, and physical needs of the listening audience.

In view of the foregoing, the Assignee is an educational organization and has evidenced an intention to operate the Station non-commercially consistent with an overall educational program. Accordingly, the nonprofit nature and educational purposes of the Assignee make it eligible, consistent with Section 73.503 of the Commission's Rules, for regulatory treatment of the Station as a noncommercial educational facility.
