

**ADDENDUM 1 TO EXHIBIT 15**

It is also expected that Navy, LLC, the joint venture entity, will change its name to “NBC Universal, LLC” upon the closing of the joint venture transaction.

By this Addendum, the parties also revise Exhibit 15 to indicate that Station Venture Holdings, LLC holds an insulated limited partnership interest in Station Venture Operations, LP and that NBC Telemundo License, LLC’s voting interest in Station Venture Holdings, LLC is 50 percent.
