

ENGINEERING STATEMENT
IN SUPPORT OF AN AMENDMENT OF APPLICATION
(BNPTTL-20000830BYW)
TO CONVERT ANALOG TO DIGITAL LPTV OPERATION
TWIN FALLS, IDAHO

MAY 2010

This engineering statement has been prepared on behalf of KM Communications, Inc. (“KM Comm”), and is in support of an amendment of pending application (BNPTTL-20000830BYW) for a new LPTV station at Twin Falls, Idaho to specify digital TV operation.

KM Comm has an application (BNPTTL-20000830BYW) pending for new LPTV station at Twin Falls, Idaho (Facility ID Number 129811) to operate analog television on Channel 30 with 1 kW effective radiated power (ERP) and 1239 meters antenna height above mean sea level using a non-directional TV antenna. It is now proposed to amend the application to specify digital LPTV operation on Channel 26 with 6.5 kW maximum ERP and 1340 meters antenna height above mean sea level using a directional TV antenna. The proposed antenna site is located more than 121 km from the top one hundred TV markets of the country.

An interference study conducted (see attached Table I) according to the FCC OET Bulletin 69 indicates the proposed digital LPTV operation on Channel 26 from the proposed site would not cause any interference to other TV, DTV or LPTV stations exceeding the Commission's guidelines.

The attached environmental statement demonstrates that there will not be any significant environmental impact from the proposed LPTV operation in accordance with 47 C.F.R. Section 1.1307.

The proposed LPTV facility complies with Section 73.1030 of the Commission's rules; therefore, notification to radio astronomy installations, radio receiving installations and FCC monitoring stations is not required.

The proposed LPTV operation would be from an existing tower which is registered (ASR No. 1040035) by the Commission and no changes are proposed to require a modification in the registration.

ENVIRONMENTAL PROTECTION ACT

Since it is planned to use an existing tower, (ASR No. 1040035), for the proposed low power digital TV operation the environmental concerns listed in Section 1.1307(a) of the Commission's rules are not pertinent; therefore, those issues have not been addressed.

An evaluation has been made to determine compliance with the Commission's specified standards for human exposure to RF fields as set forth in the OET Bulletin No. 65 dated August 1997. For a maximum effective radiated power of 6.5 kW and a radiation center of 30.3 meters above ground level, the proposed Channel 26 LPTV operation would have less than 11 microwatt per square centimeter ($\mu\text{W}/\text{cm}^2$) RF field at 2 meters above the base of tower assuming an antenna field factor of 0.2 in the downward direction.

The Commission's guidelines for Channel 26 are $1,807 \mu\text{W}/\text{cm}^2$ for the occupational/controlled, and $361 \mu\text{W}/\text{cm}^2$ for the general population/uncontrolled environment.

The above analysis indicates that members of the public and personnel working around the proposed operation would not be exposed to RF fields exceeding the Commission's guidelines. With respect to work performed on the tower, KM Comm will establish procedures to ensure that workers are not exposed to RF fields above the Commission's guidelines, by reducing or turning off the power, as appropriate.

For the reasons stated above, it is believed this proposal complies with Section 1.1307(a) and (b) of the Commission's Rules; therefore, under Section 1.1306, it is categorically excluded from environmental processing.
