CMCG Puerto Rico License LLC is the licensee of two TV stations, one Class A LPTV station and one LPTV station in Puerto Rico. Its ownership of the LPTV stations does not trigger the multiple ownership rule.

Common ownership of the two TV stations is believed consistent with Section 73.3555(b)(1)(ii) of the Commission's rules as at least 8 independently owned and operated, full power, commercial and non-commercial TV stations remain post transfer in the Puerto Rico DMA.
