Dear Mr. Jacobs:

This is in reference to the request filed September 18, 2013. RVC requests extension of the STA originally granted on June 19, 2013, to operate station KCKN(AM) with reduced power during day and night hours.<sup>1</sup> In support of the request, RVC states that the main transmitter has not yet been repaired/replaced.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

We noted that the text statement given in the request did not explain why the main transmitter could not be repaired/replaced in the past six months. As a result, although the request will be granted, if the station has not resumed operations before the expiration date shown below, a detailed explanation must be provided to justify any further extension.

Accordingly, the request for STA IS HEREBY GRANTED. Station KCKN(AM) may continue to operate during day and night hours with a reduced power of 1 kW. It will be necessary to further reduce power or cease operation if complaints of interference are received.



<sup>1</sup> KCKN(AM) is licensed for directional operation on 1020 kHz with 50 kW day and night, using different patterns.

RVC must notify the Commission when licensed operation is restored.<sup>2</sup> RVC must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310.

This authority expires on **April 17, 2014**.
