### **PARTIES TO THE APPLICATION**

OTA Broadcasting (SEA), LLC (“OTA-SEA”) is the proposed assignee in the instant application. OTA-SEA is a newly-formed Delaware limited liability company. The sole member of OTA-SEA is OTA Broadcasting, LLC (“OTA Broadcasting”), another newly-formed Delaware limited liability company.

The managing member of OTA Broadcasting is Torchlight TV Investments, LLC (“Torchlight TV”), a Delaware limited liability company which also holds 50 percent of the equity interests of OTA Broadcasting. The other members of OTA Broadcasting are Mr. Todd Lawyer, who will own 46 percent of the equity interests and serve as President and Chief Executive Officer of OTA Broadcasting, and Mr. William Tolpegin, who will own 4 percent of the equity interests and serve as Chief Financial Officer of OTA Broadcasting.

The sole member of Torchlight TV is MSD Torchlight, L.P. (“MSD Torchlight”), a Delaware limited partnership.

The sole general partner of MSD Torchlight is MSD Capital, L.P. (“MSD Capital”), a Delaware limited partnership that is the private investment firm for Mr. Michael S. Dell and members of his family and ultimately is controlled by Mr. Dell. The limited partners of MSD Torchlight are entities that are directly or indirectly wholly owned by (i) Mr. Michael S. Dell and his wife, Susan L. Dell; (ii) certain trusts for the benefit of Mr. Dell’s wife and children; and (iii) certain MSD Capital employees.

The sole general partner of MSD Capital is MSD Capital Management LLC, (“MSD Capital Management”), a Delaware limited liability company. The three managers of MSD Capital Management are Messrs Marc R. Lisker, John C. Phelan and Glenn R. Fuhrman, all of whom are employees of MSD Capital.

Michael S. Dell and Susan L. Dell are husband and wife and together own 100 percent of the combined equity interests of MSD Capital and MSD Capital Management.

All of Torchlight TV, MSD Torchlight, MSD Capital, MSD Capital Management, Messrs Dell, Lisker, Phelan and Fuhrman, and Mrs. Dell, are located c/o MSD Capital, L.P., 645 Fifth Avenue, 21st Floor, New York, New York 10022.
