Dear Mr. Neely:

This is in reference to the request filed on February 6, 2015. KRI requests further extension of the STA originally granted on October 6, 2003, to operate with parameters at variance from licensed values and/or reduced power while maintaining monitor points within licensed limits due to equipment work and re-radiation problems.<sup>1</sup> In support of the request, KRI states that the FCC's WTB staff released a letter on July 23, 2014, stating that Trimet's tower is disturbing the KKPZ pattern in violation of the Commission's rules, and that Trimet responded via letter dated August 19, 2014, that it will detune the re-radiating tower in early 2015.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.



<sup>1</sup> KKPZ is licensed for DA operation on 1330 kHz with 5 kW day and night.

Accordingly, the request for extension of STA IS HEREBY GRANTED. Station KKPZ may continue to operate with parameters at variance from licensed values and/or reduced power while maintaining monitor points within licensed limits. It will be necessary to further reduce power or cease operation if complaints of interference are received. KRI must notify the Commission when licensed operation is restored.<sup>2</sup> KRI must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310. We anticipate that Trimet will complete the detuning work in the near future which will allow KRI to resume licensed operations or to file an FCC Form 302 application (if any parameter changes are needed) before the expiration date shown below.

This authority expires on **September 4, 2015**.
