SECTION 73.207 SEPARATION STUDY

Table 1 shows the spacing study performed for the proposed WYAB facilities. All minimum spacing requirements of 47 C.F.R. §73.207 are met with the exception of WCLD-FM, 280C3, Cleveland, Mississippi. §73.215 processing is requested to resolve the short-spacing to the WCLD-FM facilities (see Exhibit 29.)
