

**EXHIBIT 15**

Parties/Ownership Information

This application, along with associated concurrently-filed applications, seeks the Commission's consent to the transfer of control of GoodRadio.TV, LLC ("GoodRadio") from Dean Goodman to Verax Capital GP, LLC ("Verax").

GoodRadio is a manager-managed limited liability company, currently with a single manager, Mr. Goodman. As the sole manager, Mr. Goodman currently has exclusive control over the day-to-day management of the company. Investment funds controlled by Verax (the "Funds") currently hold attributable but non-voting membership interests in GoodRadio. As non-voting members, the Funds currently have no power to elect or cause the election of any manager.

With this application, Verax proposes to convert the Funds' membership interests in GoodRadio from non-voting interests to voting interests, as it is permitted to do under the company's limited liability company agreement. Upon conversion of the Funds' membership interests to voting interests, control of GoodRadio will be transferred from Dean Goodman as sole Manager of GoodRadio to a new five-member Board of Managers. Three of the members of the new Board of Managers will be designated by the Funds. As a consequence, control of GoodRadio will be transferred from Mr. Goodman, who is currently the sole manager of the company, to Verax, which following the proposed conversion will designate a majority of the managers of the company.

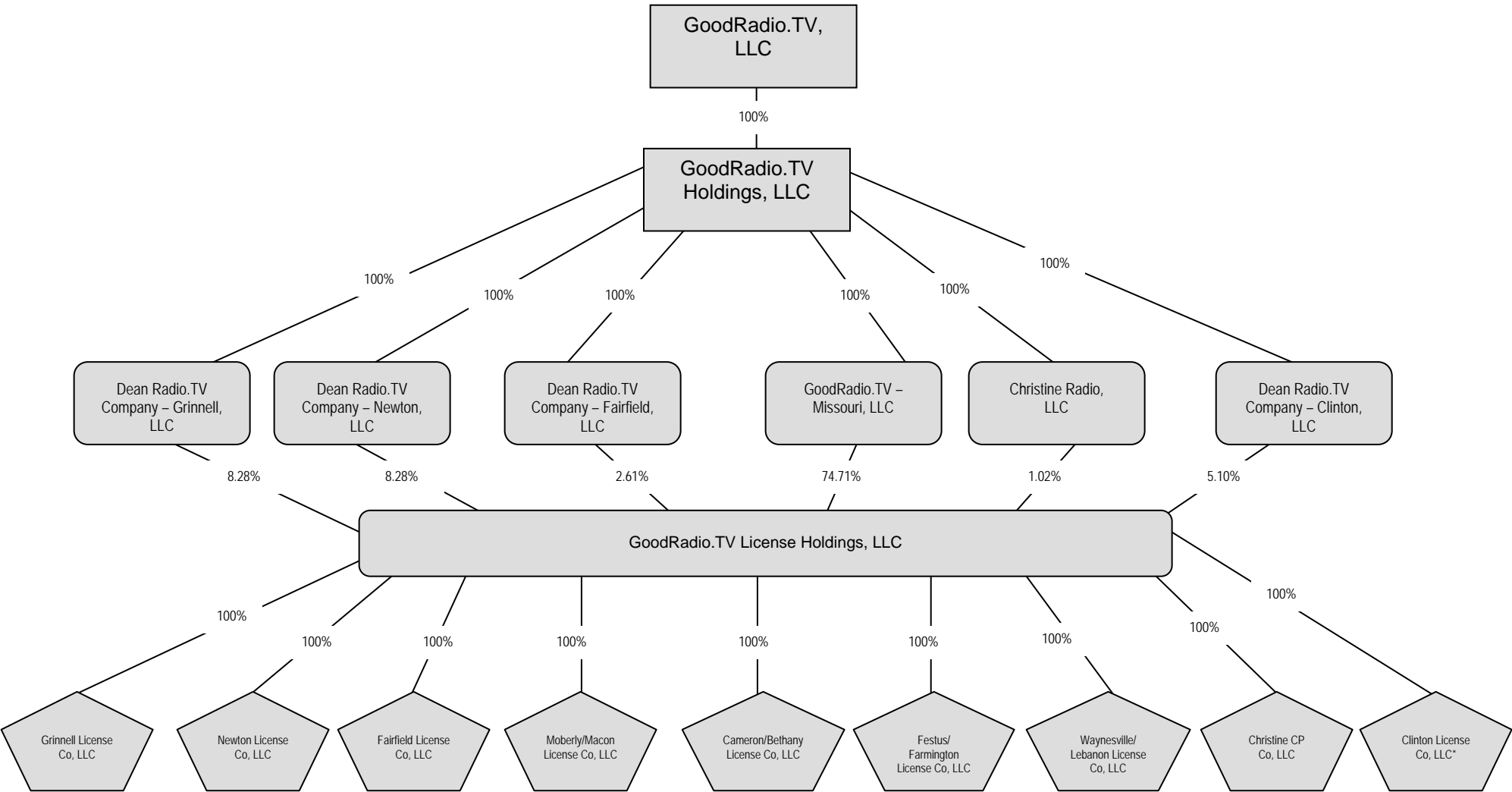

\* Clinton License Co., LLC is not an FCC licensee. GoodRadio.TV, LLC, through subsidiaries, provides programming to KDKD-FM and KDKD(AM), Clinton, Missouri pursuant to a Time Brokerage Agreement and holds an option to purchase substantially all the assets of those stations.

This application proposes no change in the ownership chain depicted in Figure 1, which will remain “as is” following the consummation of the transfer of control proposed in this application. Ownership and officer information concerning each licensee and all intervening subsidiaries up to GoodRadio is set forth in Annex A hereto. As indicated above, this application proposes no change to the ownership and officers below GoodRadio.

As indicated above, this application seeks FCC consent to the transfer of control of GoodRadio from Dean Goodman as sole Manager of GoodRadio to a new five-member Board of Managers of GoodRadio, with three of the members of the new Board of Managers, representing 60% voting control, to be selected by the Funds, which are controlled by Verax. The expansion of the Board of Managers will be effectuated pursuant to Section 5.3(d) of the Amended and Restated Limited Liability Company Agreement of GoodRadio.TV, LLC, a copy of which is included in Exhibit 6 to this application, in connection with the conversion of the Funds’ current membership interest from non-voting to voting. As provided in the Amended and Restated Limited Liability Company Agreement, upon receipt of FCC consent and following conversion of the Funds’ current membership interest from non-voting to voting, Verax (through the Funds) will own a 70.23% Class A voting membership interest in GoodRadio and, as the sole Class A unitholder, will have the right to select three of the five members of the Board of Managers. As provided in Section 5.3(d) of the Amended and Restated Limited Liability Company Agreement, the three Class A Members of the Board of GoodRadio initially to be designated by Verax will be Steven C. Hardek, Eric S. Koza, and Donald R. Kelley, who are further identified in the table set forth below. Messrs. Hardek, Koza and Kelley are the three managers of Verax, each with effectively a one-third voting interest in the company.

The remaining two members of the Board of Managers (the “Class B Members”) will be selected in accordance with Section 5.3(d) of the Amended and Restated Limited Liability Company Agreement. As provided in Section 5.3(d), the initial two Class B Members will be Dean Goodman and W. Lawrence Patrick.
