

**Multiple Ownership**

This multiple ownership showing is filed in connection with an application for modification of construction permit BMPH-20161006ACM for station KSAJ-FM, facility ID 18055, specifying facilities on Channel 253C2 at Burlingame, Kansas.

Alpha Media Licensee LLC (“Alpha”) is licensee of WIBW(AM), WIBW-FM and KTPK(FM), all Topeka, Kansas (1 AM/2 FM). These stations are geographically located in and “home” to the Topeka Nielsen Metro. Since Burlingame, Kansas is in Osage County, KSAJ-FM will be geographically located in the Topeka Nielsen Metro. No party to this application has an attributable interest in any other radio station that is located in the same market or in an overlapping station located in a non-Metro area.

As demonstrated in the attached BIA printout, the Topeka Metro contains 15 full power radio stations, allowing for common ownership of six stations, no more than four of which may be in the same service, under Section 73.3555(a) of the Commission’s rules. Therefore, common ownership by Alpha of one AM station and three FM stations in the Topeka market is permissible.

KSAJ-FM is currently licensed to Abilene, Kansas and is “home” to the Salina-Manhattan, Kansas Nielsen Metro (in which Abilene is geographically located). No party to this application has an attributable interest in any other radio station that is located in the same market or in an overlapping station located in a non-Metro area. Alpha’s ownership of a single station in the Salina-Manhattan Metro complies with Section 73.3555(a).

Accordingly, Alpha’s combinations of radio stations in the Topeka Metro (where KSAJ-FM is proposed to operate under its outstanding construction permit for Burlingame) and its ownership of one station in the Salina-Manhattan Metro (where KSAJ-FM is currently designated “home”) comply with the Commission’s local radio ownership rule.
