Dear Licensee:

CBS Radio Stations Inc. ("CBS") is hereby notified of the modification of its license for WKQC(FM), Charlotte, NC, to specify operation on Channel 284C0.

On August 7, 2012, Clear Channel Broadcasting Licensees, Inc. ("Clear Channel"), licensee of station WROO(FM), Mauldin, SC, filed a minor change construction permit application. Clear Channel's application proposed that WKQC's license and assignment be modified to specify Class C0 in lieu of Class C in accordance with the procedures set forth in Note 4 of 47 C.F.R. Section 73.3573.² Accordingly, by staff letter dated October 24, 2012, WKQC was directed to show cause why its license should not be modified to specify Channel 284C0 in lieu of Channel 284C. The letter stated that failure to respond to this letter within thirty days will result in the automatic downgrade of WKQC. As of the date of this letter, WKQC has failed to file a response to the October 24, 2012 letter, and thus, has consented to the downgrade.

Accordingly, pursuant to the authority found in Sections 4(i), 5(c)(1), 303, and 307(b) of the Communications Act of 1934, as amended, and Sections 0.61, 0.204(b), 0.283, 1.420, 73.203(b), and 73.3573 of the Commission's Rules, as amended, IT IS ORDERED, that effective the date of this letter, the FM assignment IS MODIFIED, as follows:
