TECHNICAL STATEMENT

1. This technical statement and attached exhibits were prepared on behalf of Cumulus Licensing LLC ("Cumulus"), licensee of KTLT, Channel 251C2, Anson, Texas. Cumulus is submitting an application to correct the coordinates of the licensed KTLT site. KTLT is licensed to a community within a metro county in the Abilene, Texas Arbitron Market (Market # 241). Cumulus is also the licensee of KBCY, Channel 259C1, Tye, Texas; KCDD, Channel 279C, Hamlin, Texas; and KHXS, Channel 274C1, Merkel, Texas. KBCY, KCDD and KHXS are also licensed to a community within a metro county in the Abilene, Texas market.

2. Since the four FM stations are located in the Abilene, Texas market, an analysis based on the stations in a rated market is necessary. As shown on Exhibit #1, there are twenty-three AM and FM (commercial and non-commercial) stations listed in the Abilene, Texas Arbitron Market. Cumulus would be in control of four FM stations in the market. The number of stations indicated falls in the fifteen to twenty-nine stations tier of §73.3555(a)(1)(iii) of the Commission's rules. At this level, common ownership or control of up to six stations, with no more than four in the same service, is permissible. Therefore, since Cumulus will control only four stations in this BIA/Arbitron market, the coordinate correction application for KTLT is in compliance with the rules.

3. The foregoing technical statement was prepared on behalf of Cumulus Licensing LLC by Graham Brock, Inc., its Technical Consultants. All information contained herein is true and accurate to the best of our belief and knowledge. All data relating to AM and FM facilities in the relevant BIA/Arbitron market was determined using the BIA Financial Network, Inc. Media Access Pro, Version 4.0. BIA database. We assume no liability for errors or omissions in that database which may be adverse to the information contained herein.
