As reflected in response to Section III, Question 4 of FCC Form 314, J.P. Morgan Partners (BHCA), L.P. is a wholly-owned subsidiary of both JPMP Master Fund Manager, L.P. (“Master Fund”) and Chatham Ventures, Inc. (“Chatham”). In turn, Master Fund has one general partner, JPMP Capital Corp. (“JPMP Capital”), which owns 100% of the voting interest and 25% of the equity of Master Fund. The remaining 75% equity interest in Master Fund is held by a limited partner, with four individuals (Jeffrey C. Walker, Michael J. Blutt, Arnold L. Chavkin, and John M.B. O’Conner) holding at least 5%. The limited partner is insulated from any involvement in or control of Master Fund’s media investments pursuant to the Commission-prescribed insulation criteria. JPMP Capital and Chatham are both wholly-owned subsidiaries of J.P. Morgan Chase & Co.

Master Fund is a non-managing member of Quetzal/J.P. Morgan Partners (GP), LLC, which is the general partner of Quetzal/J.P. Morgan Partners, L.P. (“Quetzal L.P.”). Quetzal L.P. holds an attributable interest in Inner City Broadcasting Corporation (“ICBC”). ICBC, through its various subsidiaries, holds an attributable interest in the following broadcast stations:
