TECHNICAL STATEMENT

1. This Technical Statement and attached exhibits were prepared on behalf of Double O Radio South Carolina Corporation ("Double O"). Double O is proposing a transfer of control and a Radio Market Analysis is required. Double O is the licensee of station WWNQ, Channel 232A, Forest Acres, South Carolina and WWNU, Channel 221C3, Irmo, South Carolina. Each of these stations is licensed to a community in a metro county in the Columbia, South Carolina Arbitron Market. Therefore, a study demonstrating compliance with the Commission's multiple ownership rules in a rated market is required.

COLUMBIA, SOUTH CAROLINA ARBITRON MARKET

2. As shown on Exhibit #1, there are thirty AM and FM (commercial and non-commercial) stations listed in the Columbia, South Carolina Arbitron Market (Market #88). Double O would have an interest in two FM stations in the same rated market. The number of stations indicated falls in the thirty to forty-four stations tier of §73.3555(a)(1)(ii) of the Commission's rules. At this level, common ownership or control of up to seven stations, with no more than four stations in the same service, is permissible. Therefore, Double O is in compliance with the Commission's multiple ownership rules for a rated market.

3. Based on the compliance shown in the rated market reviewed, the transfer of control is in compliance with the Commission's multiple ownership rules.

RADIO AND TELEVISION CROSS-OWNERSHIP REVIEW

4. Principals of Double O have an attributable interest in WACH-D, Channel 48, Columbia, South Carolina; WPDE-TV-D, Channel 16, and WWMB-D, Channel 21, Florence, South Carolina. As indicated on Exhibit #2, the digital noise limited contours of WPDE-TV-D and WWMB-D do not reach the communities of license of WWNQ or WWNU, nor do the 60 dBu contours of the two FM radio stations reach Florence, South Carolina. Therefore, the radio/TV cross ownership rules are not implicated by the transfer of control of WWNQ and WWNU with regard to WPDE-TV-D and WWMB-D.

5. However, as indicated, the digital noise limited contour of WACH-D encompasses the communities of license of WWNQ and WWNU. The 60 dBu contours of the two FM radio stations do not entirely encompass Columbia, South Carolina. Therefore, the radio/TV cross ownership rules are implicated with regard to WACH-D. A separate attachment has been prepared establishing that there are a sufficient number of independent "voices" in each market, thereby demonstrating that the proposed combination is permissible under the Commission's radio/ television cross-ownership rule.

6. The foregoing technical statement was prepared on behalf of Double O Radio South Carolina Corporation by Graham Brock, Inc., its Technical Consultants. All information

contained herein is true and accurate to the best of our belief and knowledge. All data relating to AM and FM facilities in the relevant BIA/Arbitron market was determined using the BIA Financial Network, Inc. Media Access Pro, Version 4.6. BIA database. All AM and FM data was extracted from the CDBS database. We assume no liability for errors or omissions in either database which may be adverse to the information contained herein.

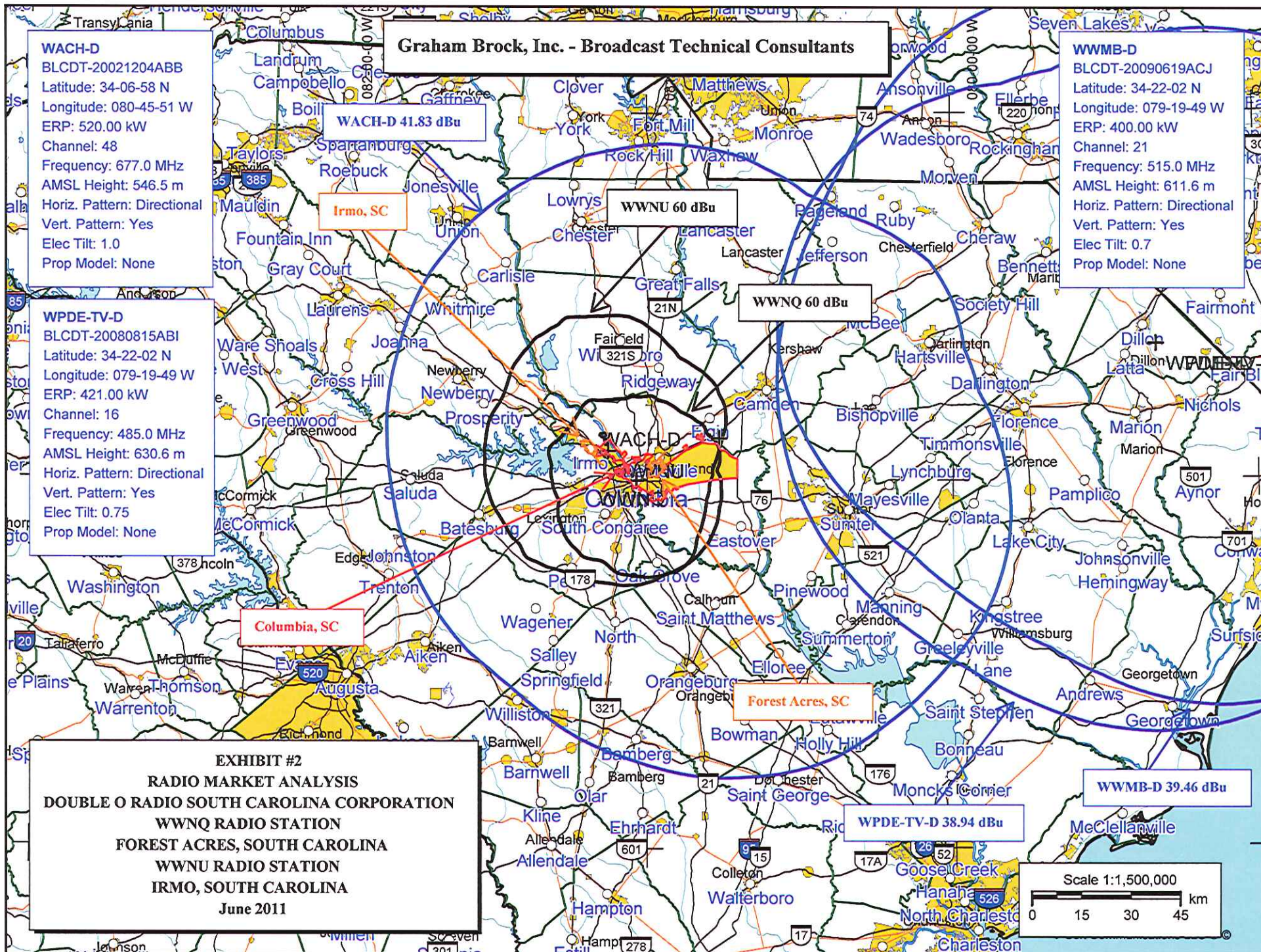


