**Request for Special Temporary Authority**

The following engineering statement and attached exhibits have been prepared for **Barrington Quincy License LLC** ("Barrington"), licensee of KHQA-TV at Hannibal, Missouri and are in support of their request for Special Temporary Authority to flash-cut to digital operations on channel 7 on February 17, 2009.<sup>1</sup>

On March 18, 2008 the applicant was granted construction permit BPCDT-20080317AGY. This construction permit authorized KHQA-DT to continue DTV operations in the post-transition environment utilizing the antenna currently in use on channel 7 for NTSC operations. Under the special temporary authority requested in this application, Barrington would commence DTV operations on channel 7 on February 17, 2009 rather than on the postponed transition date. The facilities that would be utilized for the early transition would be identical to those authorized under BPCDT-20080317AGY.

Exhibit E-1 depicts the predicted interference from the flash-cut facility to all other facilities in the region, including analog and pre-transition DTV facilities. A tabulation of the areas of interference and populations affected is contained in Exhibit E-2. As these two exhibits demonstrate, the flash-cut facility is expected to cause interference to the pre-transition analog facilities of KWWL at Waterloo, Iowa.<sup>2</sup> The level of interference is, however, less than that facility currently receives from KHQA-TV as an analog facility as depicted in Exhibits E-3 and E-4. The flash-cut KHQA-DT facility therefore represents a reduction in the level of interference caused to other facilities in the region.

The early transition of KHQA-DT from channel 29 to channel 7 would not result in a reduction in the DTV coverage associated with the facility. Exhibit E-5 depicts the noise limited service contours from the current pre-transition facilities on channel 29 in red and from the post-transition channel 7 facilities in blue. As this map demonstrates, the post-transition facility contour would encompass a larger area and serve a greater population than the current pre-transition facility. Data from the 2000 US Census indicates that 207,202 persons reside within the pre-transition noise limited contour, while 327,354 persons reside within the post-transition contour. The population within the post-transition contour is 58.0 percent greater than the population within the pre-transition contour.

It is therefore respectfully submitted that permitting KHQA-TV to flash-cut to DTV operations ahead of the postponed transition date would not result in impermissible interference to other facilities in the region, but rather a reduction in the overall interference. In addition, the flash-cut of the facility would not result in a loss of DTV service. The proposed flash-cut facilities would not constitute a significant environmental impact as they would utilize the existing KHQA antenna and tower. Furthermore, since a construction permit is already in effect for the flash-cut facilities, the Staff has already concurred that no significant environmental impact would result.




