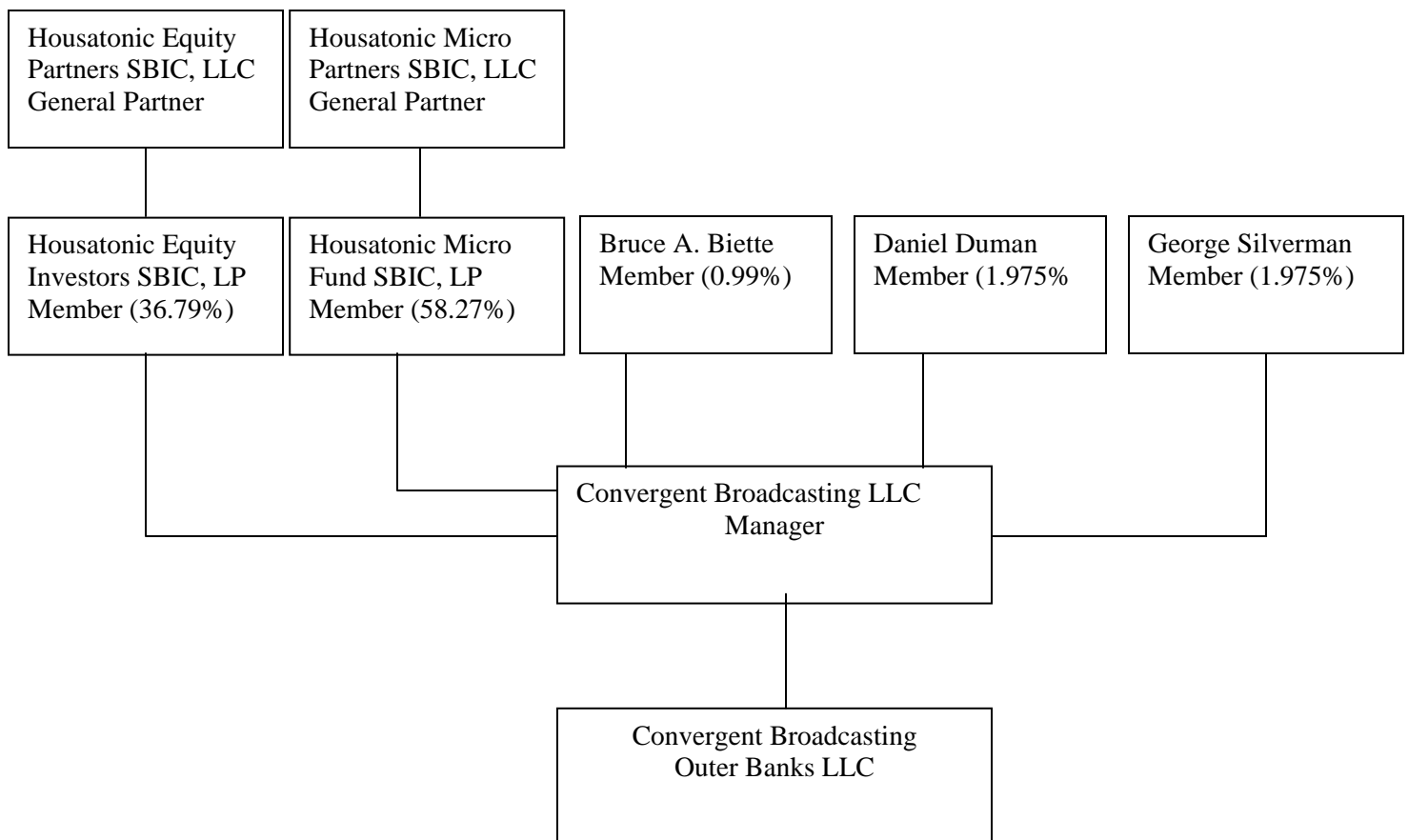


**Ownership Structure of
